SUPPLEMENTAL DECLARATION OF JOSEPH MURACA III IN SUPPORT OF DEBTORS’ APPLICATION FOR ENTRY OF AN ORDER (I) AUTHORIZING THE RETENTION AND EMPLOYMENT OF ERNST & YOUNG LLP AS AUDIT AND TAX SERVICES PROVIDER TO THE DEBTORS AND DEBTORS IN POSSESSION EFFECTIVE AS OF THE PETITION DATE AND (II) GRANTING RELATED RELIEF

I, Joseph Muraca III, hereby declare pursuant to rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”) as follows:

1. I am a partner of Ernst & Young LLP (“EY LLP”). I provide this supplemental declaration (the “Supplemental Declaration”) on behalf of EY LLP in support of the *Debtors’ Application for Entry of an Order (I) Authorizing the Retention and Employment of Ernst & Young LLP as Audit and Tax Services Provider to the Debtors and Debtors in Possession Effective as of the Petition Date and (II) Granting Related Relief* (the “Application”) [Docket No. 439]. This Supplemental Declaration supplements my declaration that was filed with this Court as Exhibit G to the Application on March 12, 2026 (the “Initial Declaration”).²

2. The facts set forth in this Supplemental Declaration are based upon my personal knowledge, upon information and belief, and upon client matter records kept in the ordinary course of business that were reviewed by me or professionals of EY LLP and EY US LLP or employees of other member firms of EYGL under my supervision and direction.

3. Debtors' counsel provided EY LLP with an updated parties in interest list ("Updated PIIL") that included additional parties and revised names that were not included in Schedule 1 annexed to the Initial Declaration. EY LLP caused the names in the Updated PIIL to be run through the Database. The disclosure schedule annexed hereto as Exhibit A lists the names in the Updated PIIL and whether a client engagement has been initiated in the Database during the last three years by EY LLP or any other EYGL member firm.³

4. To the best of my knowledge, information, and belief based on the information set forth in the Database, none of the services rendered to Parties in Interest by EY LLP or any other EYGL member firm have been in connection with the Debtors or these chapter 11 cases, except as otherwise stated herein or in the Initial Declaration.

5. Additionally, EY LLP conducted a search to determine whether EY US LLP (but not any other member firm of EYGL) has paid any person or entity that is specified on the Updated PIIL as being a Party-Retained Professional to provide professional services during the last three years. Based on its search of that database, in addition to the Party-Retained Professionals listed in paragraph 31 of the Initial Declaration, EY LLP has determined that EY US LLP has paid PricewaterhouseCoopers LLP during the last three years for professional services.

³ In Schedule 1 annexed to the Initial Declaration, EY LLP had redacted the names of certain potential M&A counterparties at the request of counsel for the Debtors. To the extent the names of those entities appear in the Updated PIIL, they no longer are redacted in Exhibit A.

6. In Paragraph 10 of the Initial Declaration mistakenly noted that EY LLP was owed \$52,000 by the Debtors in respect of services provided by EY LLP prior to the Petition Date. Instead, the correct amount is \$159,334.07. Upon approval of EY LLP's retention in these cases, EY LLP shall waive its right to receive any unpaid fees incurred on the Debtors' behalf prior to the Petition Date.

7. Paragraphs 4 through 7 of the Initial Declaration provided a summary description of the Services EY LLP has agreed to provide to the Debtors during these chapter 11 cases. Annexed hereto as Exhibit B is a list of EY LLP and EY US LLP individuals with a rank of Senior or above who are currently or who are expected to provide the Services to the Debtors during these chapter 11 cases as well as their current hourly rate if the Engagement Letters provided a rate card for their particular service.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.
