Bankruptcy Procedure, but also includes all orders and notices of any applications, petitions, motions, complaints, requests or demands, hearings, answering or reply papers, memoranda and briefs in support of any of the foregoing and any other document filed with, or otherwise brought before, this Court with respect to the above-referenced bankruptcy proceedings, whether formal or informal, written or oral, and whether sent by U.S. mail, electronic mail, courier service, hand delivery, telephone, facsimile transmission, or otherwise.

PLEASE TAKE FURTHER NOTICE that Vitesco intends that neither this Notice of Appearance and Request for Service of Papers nor any later appearance, pleading, claim or suit shall waive Vitesco's: (i) right to have final orders in non-core and certain core matters entered only after *de novo* review by a District Court Judge; (ii) right to trial by jury in any proceeding so triable in any case, controversy, or proceeding related to these bankruptcy proceedings; (iii) right to have the District Court withdraw the reference in any matter subject to mandatory or discretionary withdrawal, or (iv) any other rights, claims, actions, security interests, defenses, setoffs, or recoupments to which Vitesco is or may be entitled under agreements, in law or in equity, all of which rights, claims, actions, security interests, defenses, setoffs, and recoupments Vitesco expressly reserves.
