**DECLARATION OF DISINTERESTEDNESS  
OF FOLEY & LARDNER LLP PURSUANT TO THE ORDER  
AUTHORIZING THE DEBTORS TO RETAIN AND COMPENSATE  
PROFESSIONALS UTILIZED IN THE ORDINARY COURSE OF BUSINESS**

I, **Christopher H. Grigorian**, declare under penalty of perjury:

1. I am a partner of Foley & Lardner LLP, located at 3000 K Street, NW Suite 600, Washington, DC 20007-5143 (the “Firm”).

2. Marelli Holdings Co., Ltd. and certain of its affiliates, as debtors and debtors in possession (collectively, the “Debtors”), have requested that the Firm provide (a) general NHTSA regulatory and compliance matters, and (b) certain intellectual property counseling and filing services, as needed (the “OCP Services”), and the Firm has consented to provide such services. I am the Firm lawyer that is primarily responsible for the legal work described in this paragraph 2(a). My partner Pavan Agarwal is primarily responsible for the legal work described in this paragraph 2(b).

3. The Firm may have performed services in the past, may currently perform services, and may perform services in the future in matters unrelated to these chapter 11 cases for persons that are parties in interest in the Debtors’ chapter 11 cases. The Firm does not, however, perform services

for any such person relating to these chapter 11 cases, except for: Agrati, Inc.; Nissan North America, Inc.; Strada U.S. Payroll, LLC; MANN+HUMMEL Filtration Technology US LLC (the “Represented Clients”). The Firm provides services for the Represented Clients as creditors, customers, suppliers (e.g., payroll), or counterparties in connection with the Debtors’ chapter 11 cases, work that is unrelated to the OCP Services, and the Firm has obtained waivers from the Debtors and the Represented Clients allowing for such representation, as necessary. The Firm does not have any relationship with any such person, their attorneys, or their accountants that would be adverse to the Debtors or their estates with respect to the OCP Services.

4. As part of its customary practice, the Firm is retained in cases, proceedings, and transactions involving many different parties, some of whom may represent or be employed by the Debtors, claimants, and parties in interest in these chapter 11 cases.

5. Neither I nor any principal, partner, director, or officer of, or professional employed by, the Firm has agreed to share or will share any portion of the compensation to be received from the Debtors with any other person other than the principal and regular employees of the Firm.

6. Neither I nor any principal, partner, director, or officer of, or professional employed by, the Firm, insofar as I have been able to ascertain, holds or represents any interest adverse to the Debtors or their estates with respect to the matter(s) upon which the Firm is to be employed.

7. As of June 11, 2025, the Petition Date, the Debtors owed the Firm in the aggregate \$16,652 (work in progress) for prepetition services, the payment of which is subject to the limitations contained in title 11 of the United States Code, 11 U.S.C. §§ 101–1532.

8. As of the Petition Date, which was the date on which the Debtors commenced these chapter 11 cases, the Firm was retained to provide professional services to the Debtors. The Firm was retained on June 11, 2025.

9. As of the Petition Date, which was the date on which the Debtors commenced these chapter 11 cases, the Firm was not party to an agreement for indemnification with certain of the Debtors.

10. If the Firm should discover further facts requiring disclosure, the Firm will supplement the information contained in this Declaration.
