As of June 11, 2025, the Petition Date, the Debtors owed the Firm PLN 1512 / that is \$416,78 as per average exchange rate on 1<sup>st</sup> of September 2025 of the Polish National Bank/ for prepetition services, the payment of which is subject to the limitations contained in title 11 of the United States Code, 11 U.S.C. §§ 101-1532.
  - 8. The firm was retained on 04<sup>th</sup> of November, 2021.
- 9. As of the Petition Date, which was the date on which the Debtors commenced these chapter 11 cases, the Firm was not party to an agreement for indemnification with certain of the Debtors.
