- 8. The Firm was retained to provide professional services to the Debtors on 1. 7. 2025. The Firm also took over the legal cases previously handled by Mgr. Eva Decroix, Jiraskova 2519/25, Jihlava, 586 01, Czech Republic (legal services, Schedule 3, Tier 3 OCP List). As of June 11, 2025, the Petition Date, the Debtors owed Mgr.
