Pursuant to sections 330 and 331 of Title 11 of the United States Code (the “Bankruptcy Code”), Rule 2016 of the Federal Rules of Bankruptcy Procedure (collectively, the “Bankruptcy Rules”), and the Court’s “Order (I) Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals and (II) Granting Related Relief,” signed on or about August 5, 2025 (the “Administrative Order”), Pachulski Stang Ziehl & Jones LLP (“PSZ&J” or the “Firm”), co-counsel for the debtors and debtors in possession (“Debtors”), hereby submits its Second Monthly Application for Compensation and for Reimbursement of Expenses for the Period from August 1, 2025 through August 31, 2025 (the “Application”).

By this Application PSZ&J seeks a monthly interim allowance of compensation in the amount of \$212,478.50 and actual and necessary expenses in the amount of \$6,377.12 for a total allowance of \$218,855.62 and payment of \$169,982.80 (80% of the allowed fees) and reimbursement of \$6,377.12 (100% of the allowed expenses) for a total payment of \$176,359.92 for the period August 1, 2025 through August 31, 2025 (the “Interim Period”). In support of this Application, PSZ&J respectfully represents as follows:

Background

1. On June 11, 2025, the Debtors commenced these cases by filing voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors continue in possession of their property and continue to operate and manage their businesses as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. On June 25, 2025, the United States Trustee appointed an official committee of unsecured creditors. No trustee or examiner has been appointed in the Debtors’ chapter 11 cases.

2. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2).

3. On or about August 5, 2025, the Court signed the Administrative Order, authorizing certain professionals (“Professionals”) to submit monthly applications for interim compensation and reimbursement for expenses, pursuant to the procedures specified therein. The Administrative Order provides, among other things, that a Professional may submit monthly fee applications. If no objections are made within twenty-one (21) days after service of the monthly fee application the Debtors are authorized to pay the Professional eighty percent (80%)

of the requested fees and one hundred percent (100%) of the requested expenses. Beginning with the period ending on September 30, 2025 and at three-month intervals thereafter, each of the Professionals may file and serve an interim fee application for compensation and reimbursement of expenses sought in its monthly fee applications for that period. All fees and expenses paid are on an interim basis until final allowance by the Court.

4. The retention of PSZ&J, as co-counsel for the Debtors, was approved effective as of June 11, 2025 by this Court's "Order Authorizing the Employment and Retention of Pachulski Stang Ziehl & Jones LLP as Co-Counsel for the Debtors Effective as of the Petition Date," signed on or about August 5, 2025 (the "Retention Order"). The Retention Order authorized PSZ&J to be compensated on an hourly basis and to be reimbursed for actual and necessary out-of-pocket expenses.

PSZ&J's APPLICATION FOR COMPENSATION AND FOR REIMBURSEMENT OF EXPENSES

Compensation Paid and Its Source

5. All services for which PSZ&J requests compensation were performed for or on behalf of the Debtors.

6. PSZ&J, and any partner, of counsel, or associate thereof, have received no payment and no promises for payment from any source other than from the Debtors for services rendered or to be rendered in any capacity whatsoever in connection with the matters covered by this Application. There is no agreement or understanding between PSZ&J and any other person other than among the partners, of counsel, or associates of PSZ&J for the sharing of compensation to be received for services rendered in these cases. PSZ&J has received payments

from the Debtors during the year prior to the Petition Date in the amount of \$297,000, in connection with the preparation of initial documents and its prepetition representation of the Debtors. Upon final reconciliation of the amount actually expended prepetition, any balance remaining from the prepetition payments to PSZ&J was credited to the Debtors and utilized as PSZ&J's retainer to apply to postpetition fees and expenses pursuant to the compensation procedures approved by this Court in accordance with the Bankruptcy Code.

Fee Statements

7. The fee statements for the Interim Period are attached hereto as Exhibit A. These statements contain daily time logs describing the time spent by each attorney and paraprofessional during the Interim Period. To the best of PSZ&J's knowledge, this Application complies with sections 330 and 331 of the Bankruptcy Code, the Bankruptcy Rules and the Administrative Order. PSZ&J's time reports are initially handwritten by the attorney or paralegal performing the described services. The time reports are organized on a daily basis. PSZ&J is particularly sensitive to issues of "lumping" and, unless time was spent in one time frame on a variety of different matters for a particular client, separate time entries are set forth in the time reports. PSZ&J's charges for its professional services are based upon the time, nature, extent and value of such services and the cost of comparable services other than in a case under the Bankruptcy Code. PSZ&J has reduced its charges related to any non-working "travel time" to fifty percent (50%) of PSZ&J's standard hourly rate. To the extent it is feasible, PSZ&J professionals attempt to work during travel.

Actual and Necessary Expenses

8. A summary of actual and necessary expenses incurred by PSZ&J for the Interim Period is attached hereto as part of Exhibit A. PSZ&J customarily charges \$0.10 per page for photocopying expenses related to cases, such as these, arising in Delaware. PSZ&J's photocopying machines automatically record the number of copies made when the person that is doing the copying enters the client's account number into a device attached to the photocopier. PSZ&J summarizes each client's photocopying charges on a daily basis.

9. PSZ&J charges \$0.25 per page for out-going facsimile transmissions. There is no additional charge for long distance telephone calls on faxes. The charge for outgoing facsimile transmissions reflects PSZ&J's calculation of the actual costs incurred by PSZ&J for the machines, supplies and extra labor expenses associated with sending telecopies and is reasonable in relation to the amount charged by outside vendors who provide similar services. PSZ&J does not charge the Debtors for the receipt of faxes in these cases.

10. With respect to providers of on-line legal research services (e.g., LEXIS and WESTLAW), PSZ&J charges the standard usage rates these providers charge for computerized legal research. PSZ&J bills its clients the actual amounts charged by such services, with no premium. Any volume discount received by PSZ&J is passed on to the client.

11. PSZ&J believes the foregoing rates are the market rates that the majority of law firms charge clients for such services. In addition, PSZ&J believes that such charges are in accordance with the American Bar Association's ("ABA") guidelines, as set forth in the

ABA's Statement of Principles, dated January 12, 1995, regarding billing for disbursements and other charges.

Summary of Services Rendered

12. The names of the partners and associates of PSZ&J who have rendered professional services in this case during the Interim Period, and the paralegals and case management assistants of PSZ&J who provided services to these attorneys during the Interim Period, are set forth in the attached Exhibit A.

13. PSZ&J, by and through such persons, has prepared and assisted in the preparation of various motions and orders submitted to the Court for consideration, advised the Debtors on a regular basis with respect to various matters in connection with the Debtors' bankruptcy cases, and performed all necessary professional services which are described and narrated in detail below. PSZ&J's efforts have been extensive due to the size and complexity of the Debtors' bankruptcy cases.

Summary of Services by Project

14. The services rendered by PSZ&J during the Interim Period can be grouped into the categories set forth below. PSZ&J attempted to place the services provided in the category that best relates to such services. However, because certain services may relate to one or more categories, services pertaining to one category may in fact be included in another category. These services performed, by categories, are generally described below, with a more detailed identification of the actual services provided set forth on the attached Exhibit A. Exhibit A identifies the attorneys and paraprofessionals who rendered services relating to each category,

along with the number of hours for each individual and the total compensation sought for each category.

A. Bankruptcy Litigation

15. This category relates to work regarding motions or adversary proceedings in the Bankruptcy Court. During the Interim Period, the Firm, among other things:

(1) performed work regarding Hearing Binders and Agenda Notices; (2) performed work regarding a motion and order to extend the removal deadline; (3) reviewed and analyzed critical trade issues; (4) performed work regarding the negotiation of trade agreements pursuant to the critical vendor order; (5) reviewed and analyzed shipping contracts; (6) attended to scheduling issues; (7) reviewed and revised trade agreements; (8) reviewed and analyzed critical vendor orders and other pleadings regarding critical vendor agreement issues; (9) reviewed and analyzed issues regarding requests for production to be served on the Committee; (10) performed work regarding a motion and order to file under seal relating to information concerning arbitration; (11) performed research; (12) attended to deadline issues; (13) prepared for and attended a hearing on August 25, 2025; and (14) corresponded and conferred regarding bankruptcy litigation issues.

Fees: \$112,246.00; Hours: 89.20

B. Case Administration

16. This category relates to work regarding administration of this case.

During the Interim Period, the Firm, among other things, maintained a memorandum of critical dates, and maintained document control.

Fees: \$8,527.50; Hours: 15.10

C. Claims Administration and Objections

17. This category relates to work regarding claims administration and claims objections. During the Interim Period, the Firm, among other things, responded to creditor inquiries.

Fees: \$1,650.00; Hours: 0.90

D. PSZJ Compensation

18. This category relates to issues regarding the compensation of the Firm. During the Interim Period, the Firm, among other things, reviewed and analyzed issues regarding fee applications.

Fees: \$495.00; Hours: 0.60

E. Other Professional Compensation

19. This category relates to issues regarding the compensation of professionals, other than the Firm. During the Interim Period, the Firm, among other things: (1) reviewed and analyzed ordinary course professionals issues; (2) performed work regarding an interim compensation procedures motion and order; and (3) reviewed and analyzed issues

regarding the PricewaterhouseCoopers, Alvarez Marsal, KPMG, and Kirkland Ellis fee applications.

Fees: \$4,747.50; Hours: 5.50

F. Financial Filings

20. This category relates to issues regarding compliance with reporting requirements. During the Interim Period, the Firm, among other things: (1) performed work regarding Schedules and Statements; (2) performed work regarding the withdrawal of certain Schedules and Statements; (3) reviewed and analyzed Bankruptcy Rule 2015.3 report issues; (4) performed work regarding Monthly Operating Reports; and (5) corresponded regarding financial filings issues.

Fees: \$36,465.00; Hours: 25.90

G. Financing/Cash Collateral/Cash Management

21. This category relates to issues regarding Debtor in Possession (“DIP”) financing and use of cash collateral. During the Interim Period, the Firm, among other things: (1) reviewed and analyzed DIP financing budget issues; (2) performed work regarding a notice of updated budget; (3) performed work regarding a cash management motion; (4) performed work regarding a Fourth interim cash management order; and (5) corresponded regarding financing issues.

Fees: \$2,915.00; Hours: 3.20

H. Meetings of and Communications with Creditors

22. This category relates to meetings of creditors and communications with creditor issues. During the Interim Period, the Firm, among other things: (1) reviewed and

analyzed issues regarding a Section 341 meeting of creditors; (2) performed work regarding a notice of continued Section 341 meeting; and (3) corresponded regarding meeting of creditors issues.

Fees: \$3,135.00; Hours: 1.80

I. Plan and Disclosure Statement

23. This category relates to issues regarding a Plan of Reorganization (“Plan”) and Disclosure Statement. During the Interim Period, the Firm, among other things: (1) reviewed and analyzed Plan and Disclosure Statement issues; (2) attended to scheduling issues; and (3) corresponded regarding Plan and Disclosure Statement issues.

Fees: \$3,430.00; Hours: 2.00

J. PSZJ Retention

24. This category relates to issues regarding retention of the Firm. During the Interim Period, the Firm, among other things, performed work regarding the Firm’s retention application and order, and reviewed and responded to United States Trustee comments regarding the Firm’s retention application.

Fees: \$3,332.50; Hours: 2.30

K. Other Professional Retention

25. This category relates to issues regarding the retention of professionals, other than the Firm. During the Interim Period, the Firm, among other things: (1) performed work regarding the KPMG, PJT Partners, Alvarez Marsal, Selendy Gay, PricewaterHouse Coopers, Kirkland Ellis, Verita, and Greenberg Taurig retention applications; (2) performed

work regarding Ordinary Course Professionals issues, including declarations; and

(3) corresponded regarding retention issues.

Fees: \$32,137.50; Hours: 35.10

L. Stay Litigation

26. This category relates to issues regarding the automatic stay and relief from stay motions. During the Interim Period, the Firm, among other things: (1) reviewed and analyzed issues regarding a relief from stay motion and order; (2) performed work regarding briefing and preparation for a relief from stay motion hearing; and (3) corresponded and conferred regarding stay litigation issues.

Fees: \$3,397.50; Hours: 3.10

Valuation of Services

27. Attorneys and paraprofessionals of PSZ&J expended a total 184.70 hours in connection with their representation of the Debtors during the Interim Period, as follows:

28. The nature of work performed by these persons is fully set forth in Exhibit A attached hereto. These are PSZ&J's normal hourly rates for work of this character. The reasonable value of the services rendered by PSZ&J for the Debtors during the Interim Period is \$212,478.50.

29. In accordance with the factors enumerated in section 330 of the Bankruptcy Code, it is respectfully submitted that the amount requested by PSZ&J is fair and reasonable given (a) the complexity of the case, (b) the time expended, (c) the nature and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services other than in a case under the Bankruptcy Code. Moreover, PSZ&J has reviewed the requirements of Del. Bankr. LR 2016-2 and the Administrative Order and believes that this Application complies with such Rule and Order.

WHEREFORE, PSZ&J respectfully requests that, for the period August 1, 2025 through August 31, 2025, an interim allowance be made to PSZ&J for compensation in the amount of \$212,478.50 and actual and necessary expenses in the amount of \$6,377.12 for a total allowance of \$218,855.62 and payment of \$169,982.80 (80% of the allowed fees) and

reimbursement of \$6,377.12 (100% of the allowed expenses) be authorized for a total payment of \$176,359.92, and for such other and further relief as this Court may deem just and proper.
