**THIRD SUPPLEMENTAL DECLARATION OF KELLEY A. CORNISH IN SUPPORT  
OF THE DEBTORS' APPLICATION FOR ENTRY OF AN ORDER AUTHORIZING  
THE RETENTION AND EMPLOYMENT OF SELENDY GAY PLLC AS COUNSEL TO  
THE DEBTORS AT THE DIRECTION OF THE SPECIAL COMMITTEE  
OF MARELLI HOLDINGS CO., LTD., EFFECTIVE AS OF JUNE 11, 2025**

I, Kelley A. Cornish, in support of the *Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Selendy Gay PLLC as Counsel to the Debtors at the Direction of the Special Committee of Marelli Holdings Co., Ltd., Effective as of June 11, 2025* [ECF No. 260], dated July 11, 2025 (the "Application"),<sup>2</sup> declare as follows:

1. I am a partner of the law firm of Selendy Gay PLLC ("Selendy Gay" or the "Firm"), which maintains offices for the practice of law at 1290 Avenue of the Americas, New York, NY 10104. I am a member in good standing of the Bar of the State of New York, and I have been admitted to practice in New York. There are no disciplinary proceedings pending against me in any jurisdiction.

2. I submit this third supplemental declaration (the "Third Supplemental Declaration") to supplement (i) my original declaration in support of the Application, which was attached to the Application as Exhibit B (the "Original Declaration"), (ii) the first *Supplemental*

*Declaration of Kelley A. Cornish In Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Selendy Gay PLLC as Counsel to the Debtors at the Direction of the Special Committee of Marelli Holdings Co., Ltd., Effective as of June 11, 2025* [ECF No. 451] (the "First Supplemental Declaration"), and (iii) the *Second Supplemental Declaration of Kelley A. Cornish In Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Selendy Gay PLLC as Counsel to the Debtors at the Direction of the Special Committee of Marelli Holdings Co., Ltd., Effective as of June 11, 2025* [ECF No. 1097] (the "Second Supplemental Declaration"), to provide additional disclosures in accordance with rules 2014(a) and 2016(b) of the Bankruptcy Rules and as required under the *Order Authorizing the Retention and Employment of Selendy Gay PLLC as Counsel to the Debtors at the Direction of the Special Committee of Marelli Holdings Co., Ltd., Effective as of June 11, 2025* [ECF No. 467] (the "Retention Order"). I have personal knowledge of the facts set forth herein.

3. In the Original Declaration, I disclosed that Selendy Gay's billing rates are subject to periodic adjustments in the ordinary course of its business and in keeping with its established billing practices and procedures. I disclosed that Selendy Gay's billing rates typically change on January 1st of each year, with a step up on August 1st of each year due to the increased experience of a particular professional.

4. Pursuant to the Retention Order, Selendy Gay must provide notice of changes to its billing rates during the chapter 11 cases.

5. In accordance with ordinary practice, some billing rates for Selendy Gay's attorneys and paraprofessionals will change on January 1, 2026 due to annual rate increases.

Selendy Gay's billing rates that will take effect on January 1, 2026 for matters related to these chapter 11 cases range as follows:

Associates	\$1,165-\$1,760
Staff Attorneys	\$600-\$725
Paralegals	\$580-\$695
