I, Anthony Clark, hereby certify that:

1. On August 5, 2025, the Court entered the *Order (I) Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals and (II) Granting Related Relief* [Docket No. 477] (the “**Interim Compensation Order**”).
2. On August 26, 2025, the Court entered the *Order Authorizing the Employment and Retention of Greenberg Traurig Studio Legale Associato as Special Counsel for the Debtors Effective as of the Petition Date* [Docket No. 752] (the “**Retention Order**”).
3. In accordance with the Retention Order and Interim Compensation Order, on March 11, 2026, Greenberg Traurig, LLP (“**GT**”) filed the *Ninth Monthly Fee Application of Greenberg Traurig Studio Legale Associato for Compensation and Reimbursement of Expenses as Special Counsel for the Debtors and Debtors in Possession for the Period from February 1, 2026 Through and Including February 28, 2026* [Docket No. 1789] (the “**Application**”) with the Court.

4. Pursuant to the Notice of Application, responses to the Application were due to be filed on or by April 1, 2026. As of the date hereof, the undersigned counsel has not received any answers, objections or other responsive pleadings to the Application.

5. Accordingly, pursuant to the Interim Compensation Order and the Application, the Debtors are authorized to pay GT \$301,055.12, representing 80% of the fees requested in the Application, or \$241,379.30, and 100% of the expenses requested in the Application, or \$514.97, plus certain charges in the aggregate amount of \$59,160.85, on an interim basis without further Court order.
