**ORDER AUTHORIZING THE REORGANIZED  
DEBTORS TO REJECT CERTAIN EXECUTORY CONTRACTS**

Upon the motion (the “*Motion*”)<sup>2</sup> of the above-captioned reorganized debtors (the “*Reorganized Debtors*”) for entry of an order (this “*Order*”) authorizing the Reorganized Debtors to reject certain executory contracts, each as set forth on Exhibit 1 attached hereto (collectively, the “*Rejected Contracts*”), effective as of the Rejection Date, all as more fully set forth in the Motion; and the Court having determined that the relief requested in the Motion is in the best interests of the Reorganized Debtors, their estates, their creditors, and other parties in interest; and the Court having jurisdiction to consider the Motion and the relief requested therein in accordance with 28 U.S.C. § 1334; and the Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b) and that the Court may enter a final order consistent with Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Motion in

this district is proper pursuant to 28 U.S.C. § 1408; and the Court having found that the Reorganized Debtors provided appropriate notice of the Motion and the opportunity for a hearing on the Motion under the circumstances and that no other or further notice is necessary; and all objections, if any, to the Motion having been withdrawn, resolved, or overruled; and the Court having determined that the legal and factual bases set forth in the Motion and the hearing, if any, with respect to the Motion establish just cause for the relief granted herein; and after due deliberation thereon; and good and sufficient cause appearing therefor, it is hereby

**ORDERED, ADJUDGED, AND DECREED THAT:**

1. For the reasons stated on the record, the Reorganized Debtors are authorized to reject the Rejected Contracts identified on **Exhibit 1** attached hereto, effective as of February 28, 2026.

2. All rights of the parties to the Rejected Contracts are reserved with respect to any and all matters not addressed by this Order.

3. Notwithstanding Bankruptcy Rule 6004(h) to the extent applicable, this Order shall be effective and enforceable immediately upon entry hereof.

4. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
