**NOTICE OF VIRTUAL HEARING TO BE HELD
ON APRIL 8, 2026, AT 9:00 A.M. (PREVAILING CENTRAL TIME)
[Docket Nos. 1257, 1367]**

On August 20, 2025 (the “*Petition Date*”), ModivCare Inc. and its affiliated debtors (collectively, the “*Reorganized Debtors*”) filed voluntary petitions for relief under title 11 of the United States Code (the “*Bankruptcy Code*”) in the United States Bankruptcy Court for the Southern District of Texas, Houston Division (the “*Court*”) commencing these chapter 11 cases (the “*Chapter 11 Cases*”).

On February 6, 2026, the Reorganized Debtors filed the *Reorganized Debtors’ Second Omnibus Objection to Certain Claims* [Docket No. 1257] (the “*Omnibus Objection*”), and on March 10, 2026, Jackson Parish Ambulance Service District filed a response to the Omnibus Objection (the “*Response*”).

A hearing will be held on the Omnibus Objection and the Response before the Honorable Alfredo R. Pérez, United States Bankruptcy Judge, in Courtroom 400 of the United States Bankruptcy Court for the Southern District of Texas, 515 Rusk Street, Houston, Texas 77002 (the “*Court*”) on **April 8, 2026, at 9:00 a.m. (prevailing Central Time)** (the “*Hearing*”).

The Hearing will be conducted **virtually only**.² **No in-person attendance will be permitted.** Audio communication will be by use of the Court’s dial-in-facility. You may access the facility at (832) 917-1510. Once connected, you will be asked to enter the conference room number. Judge Pérez’s conference room number is 282694. Video communication will be by the use of the GoToMeeting platform. Connect via the free GoToMeeting application or click the link
