**GLOBAL NOTES, METHODOLOGY,  
AND SPECIFIC DISCLOSURES REGARDING  
THE REORGANIZED DEBTORS’ POST-CONFIRMATION REPORT**

The accompanying Post-Confirmation Report (“*PCR*”) has been prepared by ModivCare Inc. and its affiliated reorganized debtors (collectively, the “*Reorganized Debtors*”) in the above-captioned Chapter 11 Cases, to comply with the reporting requirements of the Office of the United States Trustee for Region 7 (the “*U.S. Trustee*”) and applicable bankruptcy reporting guidelines. The information contained in these global notes (these “*Global Notes*”) is unaudited, limited in scope, and not prepared in accordance with generally accepted accounting principles in the United States (“*GAAP*”). These Global Notes contain information that is applicable to each Post-Confirmation Report filed in the Chapter 11 Cases contemporaneously herewith (collectively, the “*Reports*”), each of which corresponds to one of the Reorganized Debtors’ five business segments. In preparing this PCR the Reorganized Debtors relied on financial data available from the books and records available to them at the time of such preparation, as well as certain filings from the docket in the chapter 11 cases of the Reorganized Debtors. The information presented in the Reports is preliminary and subject to further material review, adjustment, and reclassification as additional information becomes available. This PCR should not be relied upon for valuation, investment, or any other purpose.

On December 15, 2025, the United States Bankruptcy Court for the Southern District of Texas (the “*Bankruptcy Court*”) entered an order [Docket No. 1055], which, among other things, confirmed the *Second Amended Joint Chapter 11 Plan of Reorganization of ModivCare Inc. and Its Debtor Affiliates* [Docket No. 1055, Ex. A] (the “*Plan*”). On December 29, 2025 (the “*Plan Effective Date*”), the restructuring transactions contemplated by the Plan were substantially consummated, the Plan became effective, and the Reorganized Debtors emerged from bankruptcy.

### **Part 1: Summary of Transfers**

Pursuant to the Region 7 guidelines, the amounts presented in Part 1(A): Total Cash Disbursements “Current Quarter” and “Total Since Effective Date” match in this first PCR and reflect cash disbursements made between January 1, 2026, and March 31, 2026. Cash disbursements made in the period between the Plan Effective Date and December 31, 2025, were reported in the December MORs. As such, these PCRs exclude those disbursements from the “Total Since Effective Date” field.

The non-cash securities transferred in Part 1(B) disclosed in the PCR of the Lead Debtor is reported as the midpoint of the Equity Value stated in the Valuation Analysis, as filed at Docket No. 350, Exhibit E.

### **Part 2: Professional Fees and Expenses**

Amounts reported in the “Current Quarter” columns of the Lead Debtor reflect payments approved and made, as applicable, to retained Professionals between January 1, 2026, and March 31, 2026, where the fees and expenses corresponding to such payments were incurred prior to the Effective Date.

### **Part 3: Recoveries of the Holders of Claims and Interests under Confirmed Plan**

The information in this section of the PCR excludes payments made prior to confirmation of the Plan under authority granted by the First Day Orders to pay prepetition liabilities of the Reorganized Debtors.

Given the ongoing nature of the Reorganized Debtors’ claims reconciliation process, the Reorganized Debtors’ used reasonable efforts to calculate Allowed Claims and Total Anticipated Payments Under Plan.

For purposes of providing a preliminary estimate of distributions for the PCR, claims are calculated at the lead debtor entity, ModivCare Inc.. Nothing contained in the PCR or these Global Notes shall be interpreted to supersede or contradict the terms of the Plan.

The reported value of Allowed Secured Claims in the PCR of the Lead Debtor is representative of the value of the Secured debt as stated in the filed Schedule D of the Statement of Financial Affairs. The corresponding Total Anticipated Payments Under Plan reflect the application of the Recovery estimates as stated in the Plan.

Allowed Other Priority Claims were not scheduled and are expected to receive 100% recovery.

The reported value of Allowed General Unsecured Claims in the PCR of the Lead Debtor is representative of the reported number in the filed Part 2 of Schedule E/F. The corresponding Anticipated Payments reflect the value of cash and equity expected to flow to General Unsecured Creditors, or, the **“GUC Cashout Value.”**

The values ascribed to Allowed Claims and Anticipated Recoveries, including, without limitation, the GUC Cashout Value, are estimates that are subject to material change given, as

noted above, the Reorganized Debtors' claims-reconciliation process remains ongoing. As the claims-reconciliation process continues, certain claims will be allowed while others will be disallowed and expunged which, in turn, will impact the amount of Allowed Claims and the correspondent Anticipated Recoveries. The estimates set forth herein regarding the Allowed Claims and Anticipated Recoveries, including, without limitation, the GUC Cashout Value, are solely presented for purposes of the Reorganized Debtors' post-confirmation reporting, and such estimates should not be relied on for any purpose, including, but not limited to, for purposes of a creditor determining whether to transfer, settle, or otherwise dispose of any pending claim.

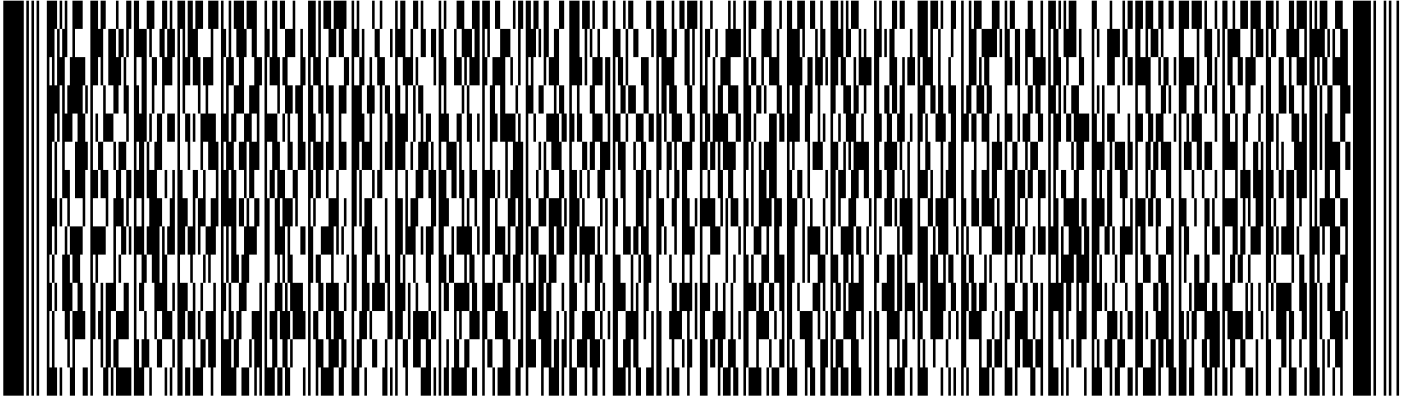

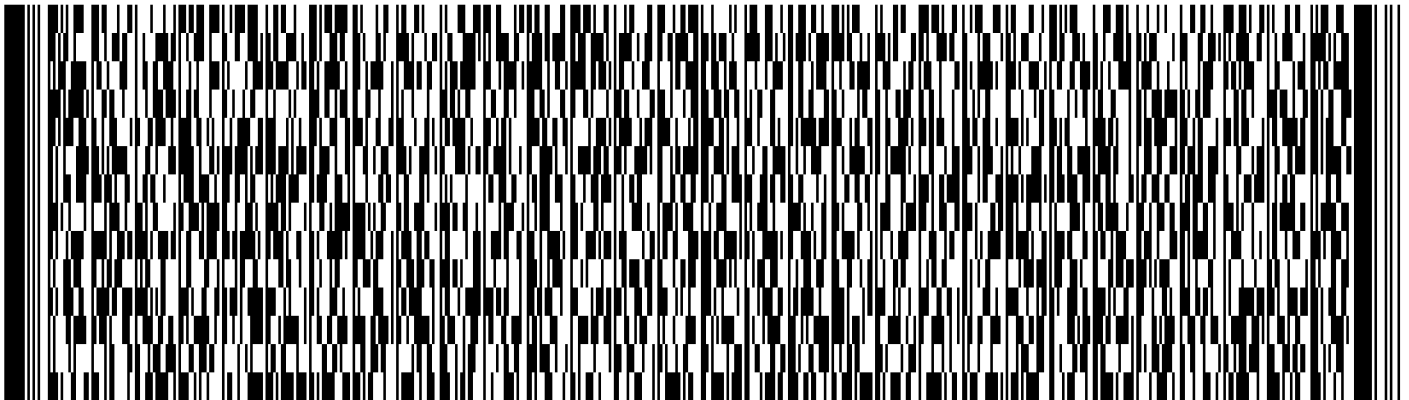

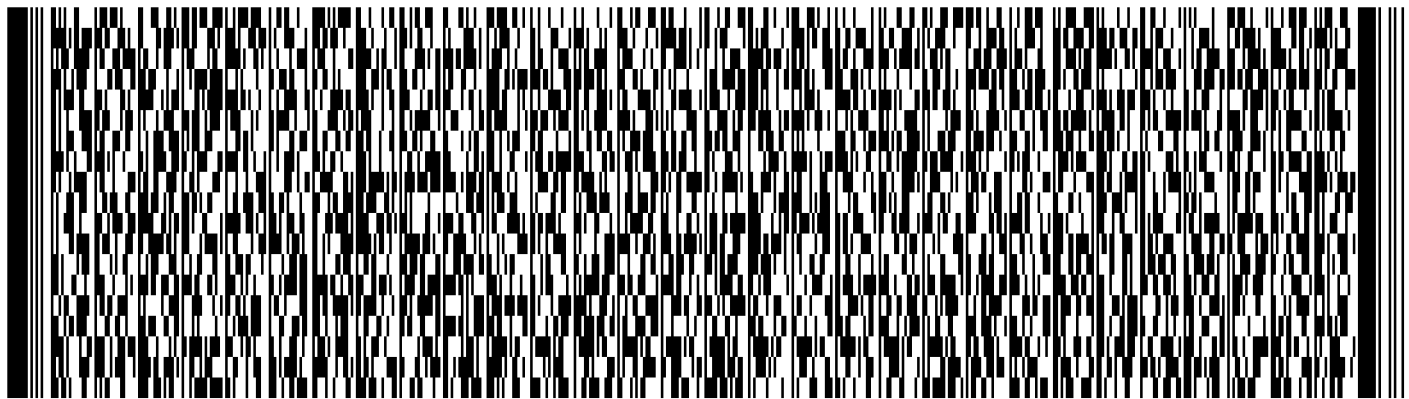
Bankruptcy Table 51-100
