I am sending my documents directly to you because I have no idea who the person is that sent me paperwork: Verita? 222 North Pacific Coast Highway Ste. 300: El Segundo, CA 90245. I am named in the Bankruptcy filing, and I had no idea what they are saying that they are attempting to object to money owed to me. I am not late, because I did not know about this bankruptcy filing. I only knew they had not paid me.

I am enclosing documents that I sent to MODIVCARE stating that they had not paid me for travel reimbursement. Please accept this document as true and accurate. They could "maybe" provide some dates and payments, but I did not receive this money to the best of my knowledge. I have also had some significant hospitalizations over the last nine months, so please understand that I am just getting to this paperwork. I have a significant concussion still and need to be represented. They owe me money.

Some of the paperwork states that it was paid, but I did not get the money so I asked for a copy of the cancelled check and they never sent it. Up to page 6 there were 714 miles not reimbursed for. Then starting on page 7, 8. And 9 is another 475 miles not reimbursed for. That is a total for 1,189 miles at the rate of .50 per mile or \$594.50. That is my claim amount in this case.

NOTICE OF REORGANIZED DEBTORS' SIXTH OMNIBUS CLAIM OBJECTION

This is an objection to your claim. This objection asks the Court to disallow the claim you filed in this bankruptcy case. If you do not file a response within 30 days after the objection was served on you, your claim may be disallowed without a hearing.

Claimants receiving this notice (this "Notice") should locate the affected claims and the name of the creditor who filed it on the exhibits attached to the Omnibus Objection (as defined below). If you do not file a response by April 25, 2026, at 4:00 p.m. (prevailing Central Time), your claim may be disallowed without a hearing.

If you timely file a response that cannot be resolved, a hearing will be scheduled.

INTRODUCTION

Why am I receiving this document? You are receiving this Notice because ModivCare Inc. and its debtor affiliates (referred to as the "Reorganized Debtors") have filed the Objection attached hereto as Appendix 1 (the "Omnibus Objection") to your claim(s).²

Why is my claim being objected to? As summarized in the exhibit(s) to the Omnibus Objection, the Reorganized Debtors believe that the Proof of Claim that you filed or that was filed on your behalf is deficient because: the Proof of Claim was not timely filed by the deadline set by the Court.

Where can I find out which claim is being objected to? The appendices attached hereto contain information needed for you to search for and identify the name of the creditor who filed the

I have had to cancel numerous appointments because I am not receiving reimbursement checks for numerous appointments. I am giving you the Trip numbers and dates that I believe I have not been paid for. Send me

copies of the cancelled checks for these dates. Where are you sending checks? Since it has been a long times since I have received them I need to have complete accountability for the trips and transportation for my medically necessary mileage.

I had to cancel, because of this lack of payment by you, TRIPS on 1-17 for pain management, 1-19 for hearing loss, trip on 1-24 for diabetic foot care/orthopedic care, trip on 1-31 for pulmonary care, and 2-3 for physical therapy. PLUS MANY MORE TRIPS TO MEDICAL APPOINTMENTS THAT I WAS UNABLE TO GO TO BASED ON NON-PAYMENT OF THESE TRIPS. This was updated by phone with ModivCare on 4-11-2023.

What do they actually do with the trip logs that have been signed by my doctors? I have copies of EVERYTHING to back my words. Shame on them. Please make them pay immediately or I will have to start again cancelling my medically necessary appointments.
