ORDER GRANTING COMPLEX CHAPTER 11 BANKRUPTCY CASES TREATMENT

 - c. Appendix A to the Local District Court Civil Rules applies.
 - d. If a conflict exists between the Bankruptcy Local Rules and the Procedures for Complex Chapter 11 Cases in the Southern District of Texas, the
