PLEASE TAKE FURTHER NOTICE that on March 12, 2025, the above-captioned debtors and debtors in possession (the "Debtors") notified the Court of their continued discussions with the Prepetition Agent and the Statutory Unsecured Claimholders' Committee regarding the terms of a proposed order (the "Proposed Eighth Interim Order") to further extend the consensual use of Cash Collateral and requested to adjourn the hearing with respect to the Proposed Eighth Interim Order.

PLEASE TAKE FURTHER NOTICE that the hearing on the Proposed Eighth Interim Order is adjourned to March 17, 2025 at 10:00 a.m. (prevailing Central Time) before the Honorable Marvin Isgur at the United States Bankruptcy Court for the Southern District of Texas, Houston Division.
