**STIPULATION REGARDING WITHDRAWAL OF CERTAIN
PROOFS OF CLAIM FILED BY WEITZ & LUXENBERG, P.C.**

Aldrich Pump LLC ("Aldrich") and Murray Boiler LLC ("Murray"), as debtors and debtors in possession (together, the "Debtors") jointly administered in the above-captioned case, and Weitz & Luxenberg, P.C. ("Weitz"), as counsel for certain asbestos claimants (the "Claimants"), hereby stipulate (the "Stipulation") as follows:

WHEREAS, on June 18, 2020, the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code, and by an order entered on June 25, 2020, the Debtors' cases have been consolidated for procedural purposes only and are being jointly administered under Case No. 30608 [Dkt. 114].

WHEREAS, on April 4, 2022, the Court entered an order ("Bar Date Order") establishing the last date and time for filing certain proofs of claim against the Debtors as July 29, 2022 [Dkt. 1093] (the "Bar Date"). The proof of claim form approved by the Court requires creditors to designate the specific Debtor against which the creditor asserts its claim.

WHEREAS, Weitz, on behalf of the Claimants, filed Proofs of Claim (the "Weitz Proofs of Claim"), which are detailed on Exhibit 1 attached hereto, against one or both Debtors, asserting various asbestos personal injury related claims.

WHEREAS, upon review of the Debtors' books and records, counsel to the Debtors initiated discussions with counsel to the Claimants regarding, among other things, whether the Weitz Proofs of Claim were properly asserted against both Debtors.

WHEREAS, Weitz has determined that the Claimants listed on the attached Exhibit 1 do not have a prepetition mesothelioma claim as defined by the Bar Date Order against either Aldrich or Murray and, therefore, those Weitz Proofs of Claim should be withdrawn in their entirety.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the Debtors and counsel to the Claimants, as follows:

1. The Weitz Proofs of Claim, which are detailed in Exhibit 1 attached hereto, shall be withdrawn in their entirety, as to Aldrich, and Murray, as applicable.

2. Notwithstanding anything to the contrary set forth in the Bar Date Order, the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, or the Rules of Practice and Procedure of the United States Bankruptcy Court for the Western District of North Carolina, this Stipulation shall constitute the withdrawal of each Weitz Proof of Claim detailed in Exhibit 1 attached hereto.
