ORDER GRANTING THE SEVENTH INTERIM APPLICATION OF WINSTON & STRAWN LLP FOR ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES WITH RESPECT TO SERVICES RENDERED AS SPECIAL LITIGATION COUNSEL TO THE OFFICIAL COMMITTEE OF ASBESTOS PERSONAL INJURY CLAIMANTS FOR THE PERIOD JANUARY 1, 2024 THROUGH APRIL 30, 2024

This matter coming before the Court on the Seventh Interim Application of Winston & Strawn LLP for Allowance of Compensation and Reimbursement of Expenses With Respect to Services Rendered as Special Litigation Counsel to the Official Committee of Asbestos Personal Injury Claimants for the Period January 1, 2024 Through April 30, 2024 [Doc. 2537] (the "Seventh Interim Fee Application")2 filed by Winston & Strawn LLP ("Winston"), special

litigation counsel to the Official Committee of Asbestos Personal Injury Claimants (the "Committee") of Aldrich Pump LLC and Murray Boiler LLC (collectively, the "Debtors"); the Court having reviewed the Seventh Interim Fee Application; the Court having found that: (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b); (c) notice of the Seventh Interim Fee Application was sufficient pursuant to Local Rule 2002-1(g) and the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Retained Professionals [Doc. 171] (the "Interim Fee Order") and no other or further notice is required; (d) the compensation requested in the Seventh Interim Fee Application is reasonable and for actual and necessary services rendered by Winston on behalf of the Committee during the period from January 1, 2024 through April 30, 2024 (the "Fee Period"); (e) the expenses for which reimbursement is sought in the Seventh Interim Fee Application are actual and necessary expenses incurred by Winston during the Fee Period on behalf of the Committee; and (f) the Seventh Interim Fee Application fully complies with the Interim Fee Order, the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and the Guidelines; and the Court having determined that the legal and factual bases set forth in the Seventh Interim Fee Application establish just cause for the relief granted herein:

IT IS HEREBY ORDERED AND DECREED THAT:

- 1. The Seventh Interim Fee Application is GRANTED.
- 2. Winston is awarded, on an interim basis, compensation for professional services rendered during the Fee Period in the amount of \$690,188.00 and reimbursement for actual and necessary expenses incurred by Winston during the Fee Period in the amount of \$5,369.72.³

- 5. This Court shall retain jurisdiction over any and all matters arising from or related to the implementation, enforcement, or interpretation of this Order.
