

## ORDER GRANTING THE FOURTEENTH INTERIM APPLICATION OF JOSEPH W. GRIER, III, THE FUTURE CLAIMANTS' REPRESENTATIVE, FOR ALLOWANCE OF COMPENSATION FOR SERVICES RENDERED AND FOR REIMBURSEMENT OF EXPENSES FOR THE PERIOD OF <u>OCTOBER 1, 2024 THROUGH JANUARY 31, 2025</u>

This matter came before the Court on the Fourteenth Interim Application of Joseph W.

Grier, III, for Allowance of Compensation for Services Rendered and for Reimbursement of

Expenses for the Period from October1, 2024 through January 31, 2025 (the "Application") (Doc.

No. 2585) filed by Joseph W. Grier, III ("Grier"), the Future Claimants' Representative, through

counsel, in the above-referenced chapter 11 cases (the "FCR"). The Court having reviewed the

Application and the record in this case having found that (a) the Court has jurisdiction to determine

this matter pursuant to 28 U.S.C. §§ 157 and 1334, (b) this is a core proceeding pursuant to 28

U.S.C. § 157(b), (c) notice of the Application and the notice of opportunity for hearing was served upon the parties required by Local Rule 2002-1(g) and the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Retained Professionals* (Doc. No. 171) (the "Interim Compensation Order"), and no other or further notice is required, (d) the compensation requested in the Application is reasonable and reflects actual and necessary services rendered by Grier as the FCR during the period from October 1, 2024 through January 31, 2025 (the "Compensation Period"), (e) the expenses for which reimbursement is sought in the Application reflect actual and necessary expenses incurred by Grier during the Compensation Period, and (f) the Application fully complies with the Interim Compensation Order, the Bankruptcy Code, the Bankruptcy Rules, and this Court's Local Rules and Compensation Guidelines; and the Court having determined that the legal and factual bases set forth in the Application establish just cause for the relief granted herein;

IT IS, THEREFORE, ORDERED that:

1) The Application is GRANTED.

2) Grier is awarded, on an interim basis, compensation for professional services rendered during the Compensation Period in the amount of \$27,640.00 and reimbursement for actual and necessary expenses incurred by Grier during the Compensation Period of \$9.80.

3) The Debtors are authorized and directed to pay promptly to Grier the amount of fees and expenses approved in this Order, to the extent that such amounts have not previously been paid by the Debtors.

 The Debtors and Grier are authorized and empowered to take all actions necessary to implement the relief granted in this Order.
