**ORDER GRANTING THE FOURTEENTH INTERIM FEE APPLICATION OF
ROBINSON & COLE LLP, AS COUNSEL TO THE OFFICIAL COMMITTEE OF
ASBESTOS PERSONAL INJURY CLAIMANTS FOR PAYMENT OF INTERIM
COMPENSATION AND REIMBURSEMENT OF EXPENSES INCURRED FOR THE
PERIOD OCTOBER 1, 2024 THROUGH JANUARY 31, 2025**

This matter coming before the Court on the *Fourteenth Interim Fee Application of Robinson & Cole LLP, as Counsel to the Official Committee of Asbestos Personal Injury Claimants for Payment of Interim Compensation and Reimbursement of Expenses Incurred for the Period October 1, 2024 through January 31, 2025* (the “Fourteenth Interim Fee Application”)² filed by Robinson & Cole LLP (“Robinson & Cole”) [Dkt. 2749], counsel to the Official Committee of Asbestos Personal Injury Claimants (the “Committee”); the Court having reviewed

the Fourteenth Interim Fee Application; the Court having found that: (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b); (c) notice of the Fourteenth Interim Fee Application was sufficient pursuant to Local Rule 2002-1(g) and the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Retained Professionals* [Dkt. No. 171] (the “Interim Fee Order”) and no other or further notice is required; (d) the compensation requested in the Fourteenth Interim Fee Application is reasonable and for actual and necessary services rendered by Robinson & Cole on behalf of the Committee during the period of October 1, 2024 through January 31, 2025 (the “Fee Period”); (e) the expenses for which reimbursement is sought in the Fourteenth Interim Fee Application are actual and necessary expenses incurred by Robinson & Cole during the Fee Period on behalf of the Committee; and (f) the Fourteenth Interim Fee Application fully complies with the Interim Fee Order, the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and the Guidelines; and the Court having determined that the legal and factual bases set forth in the Fourteenth Interim Fee Application establish just cause for the relief granted herein:

1. The Fourteenth Interim Fee Application is GRANTED.
2. Robinson & Cole is awarded, on an interim basis, compensation for professional services rendered during the Fee Period in the amount of \$905,775.00 and reimbursement for actual and necessary expenses incurred by Robinson & Cole during the Fee Period in the amount of \$36,439.08.
3. The Debtors are authorized and directed to pay Robinson & Cole promptly the fees and expenses approved in this Order to the extent such amounts have not been paid previously by the Debtors.

4. The Debtors and Robinson & Cole are authorized and empowered to take all actions necessary to implement the relief granted in this Order.

5. This Court shall retain jurisdiction over any and all matters arising from or related to the implementation, enforcement, or interpretation of this Order.
