EX PARTE MOTION FOR ORDER SHORTENING NOTICE

The Official Committee of Asbestos Personal Injury Claimants (the "Committee") of Aldrich Pump LLC, et al., (the "Debtors") hereby files this Ex Parte Motion for Order Shortening Notice (this "Motion to Shorten Notice") requesting, pursuant to Local Bankruptcy Rule 9006-1, shortened notice of the Motion to Amend the Second Amended Case Management Order for Estimation of Asbestos Claims (the "Expert Report Confidentiality Motion"). In support of this Motion to Shorten Notice, the Committee respectfully states as follows:

1. Contemporaneously herewith, the Committee filed the Expert Report Confidentiality Motion which seeks to enhance the confidentiality protections governing the Initial Expert Reports.² Specifically, the Expert Report Confidentiality Motion seeks entry of an order (a) limiting the use of the Initial Estimation Reports to the estimation proceeding in this case; and (b) restricting access to and production of the Initial Expert Reports to the parties to the estimation proceeding.

- 2. As set forth in greater detail in the Expert Report Confidentiality Motion, the Debtors, the FCR, and the Committee have communicated regarding the treatment and disclosure of the Initial Expert Reports following their exchange on September 15, 2025. These communications identified a disagreement among the Parties: notwithstanding the Court's comments regarding the non-filing of the Initial Expert Reports, the communications indicated to the Committee that the FCR intended to imminently file the Initial Expert Reports for the Court's review and that the Debtors intended to share the reports with other entities that were requesting the reports from the Debtors.
- 3. A hearing date in these jointly administered chapter 11 cases is scheduled for October 23, 2025. Accordingly, the Committee is requesting that the required notice period for the Expert Report Confidentiality Motion be shortened so that it may be heard on October 23, 2025.
- 4. This motion is timely in that it has been filed as soon as possible following the identification of the remaining disagreement.
- 5. The Debtors and the FCR—the only parties affected by the Expert Report Confidentiality Motion—have consented to the Committee's request to shorten notice. Additionally, all parties to these proceedings shall receive notice via ECF of the Expert Report Confidentiality Motion and this Motion to Shorten Notice on October 10, 2025, immediately upon its filing.
- 6. Given the consent of the Debtors and the FCR, and the broad notice provided to other parties and their right to respond in advance of the hearing on October 23, the Committee submits that shortened notice is sufficient and justified under the circumstances, and no party will be prejudiced by such shortened notice in relation to the Expert Report Confidentiality Motion.

WHEREFORE, the Committee respectfully requests the Court enter an Order, in the form attached hereto as **Exhibit A**, granting the relief requested in this Motion to Shorten Notice and granting such further relief as the Court deems just and proper.
