**PLEASE TAKE NOTICE OF THE FOLLOWING:**

1. On February 15, 2022, the Bankruptcy Court entered its *Order Authorizing the Debtors to Establish a Qualified Settlement Fund for Payment of Asbestos Claims* [Docket No. 994] (the “Order”) and authorized the Debtors to enter into that certain Aldrich/Murray Settlement Facility Agreement (the “Settlement Facility Agreement”)<sup>2</sup> by and among the Debtors, Trane Technologies Company LLC, Trane U.S. Inc., and U.S. Bank National Association, as trustee (the “Trustee”).

2. In accordance with Section 3.2(b)(ii) and (c) of the Settlement Facility Agreement, the Trustee hereby submits a report summarizing the number and amount of payments in respect of Asbestos Claims, classified by disease type and designated as being in respect of Aldrich Asbestos Claims or Murray Asbestos Claims, as applicable, requested from and paid by the Settlement Facility, for the period from January 1, 2026, through and including March 31, 2026
