Due to our current financial challenges, we have considered and implemented a variety of options to improve efficiency and reduce cost, while maintaining our present staffing levels. However, at present, we now find that we must reduce our total workforce. Consequently, effective October 28, 2019, you will be terminated from your employment with Astria Regional Medical Center. We value your contribution to the organization.

Return of Hospital Property: All hospital property, to include identification badge and office keys, must be returned to the Human Resources Director on October 29, 2019.

Severance: You are being offered four weeks' severance in consideration for your agreement to a waiver and release of claims.

Employment Verification: Our records will show that you left Astria Regional Medical Center due to position elimination. To protect the privacy of its former employees, Astria Regional Medical Center does not normally provide references and its policy on employment verification is to report job title, position held and dates of employment. Your status will be reported as having been employed with Astria Regional Medical Center from 02/26/13 to 10/29/19. Your last official job title will be recorded as Social Worker MSW at Astria Regional Medical Center.

Benefit Plans: If you have been a participant on the hospital's benefits plans, you will be covered until October 31, 2019. You will be eligible to receive benefits under COBRA. A COBRA notice will be sent to you in the mail explaining your options.
