**WIND-DOWN DEBTOR’S NOTICE OF INTENT TO ADDUCE TESTIMONY FROM A
REMOTE LOCATION BY TELEPHONE AND VIDEO TECHNOLOGY**

1. This Notice is filed pursuant to BLR 9017-1(c)(2)(B) by Auto Plus Auto Sales LLC, the Wind-Down Debtor (the “Wind-Down Debtor” and prior to the Effective Date², the Debtor, the “Debtor”).
2. This Notice pertains to the matters scheduled for hearing in this case on **June 17, 2025, at 10:00 a.m. (prevailing Central Time)**.
3. The party filing this Notice may call the following witness to testify at the scheduled hearing by telephone and video technology:

 (A) Susanne Edwards, Former Assistant Vice President of Finance for Debtor
4. **Any party-in-interest may object to this notice within 3 days of its filing on the Court’s docket. If no party-in-interest files a timely objection, the Court will allow the identified witnesses to give testimony remotely using the Court’s telephone and video technology. If the Court does not authorize the testimony to be taken remotely, the Court will schedule a date for the witness's testimony to be given live in open court. Both the witness and the objector must appear in person at the scheduled date.**
5. This Notice may be withdrawn at any time prior to the scheduled hearing or trial.
