Ernst & Young LLP ("EY LLP") respectfully represents as follows in support of this first

and final fee application (this "Application"):

1. Pursuant to sections 330 and 331 of title 11 of the United States Code, 11 U.S.C.

§§ 101, *et seq.* (the "<u>Bankruptcy Code</u>"), rule 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), rule 2016-1 of the Local Bankruptcy Rules for the United States Bankruptcy Court for the Southern District of Texas (the "<u>Bankruptcy Local Rules</u>"), and the confirmed *Joint Prepackaged Plan of Reorganization of Avaya Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 50] (as amended, supplemented, or

otherwise modified from time to time, the "<u>Plan</u>"),² EY LLP as valuation, financial accounting advisory, investigative, and tax services provider for the debtors in the above-captioned chapter 11 cases (before the Effective Date of the Plan, collectively, the "<u>Debtors</u>," and after the Effective Date of the Plan, collectively, the "<u>Reorganized Debtors</u>") hereby files this Application for allowance of compensation for professional services performed by EY LLP during the period commencing February 14, 2023, through and including March 22, 2023 (the "<u>Final</u> Compensation Period") in the amount of \$161,732.90.

2. In support of this Application, EY LLP submits the declaration of Govind D. Gupta, a Principal of EY LLP (the "<u>Gupta Declaration</u>"), which is attached hereto as <u>Exhibit A</u> and incorporated by reference.

Jurisdiction and Venue

3. The United States Bankruptcy Court for the Southern District of Texas (the "<u>Court</u>") has jurisdiction to consider this matter pursuant to 28 U.S.C. § 1334.

4. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b).

5. The statutory and other bases for the relief requested herein are sections 330 and 331 of the Bankruptcy Code, Bankruptcy Rule 2016, Bankruptcy Local Rule 2016-1 and the Plan.

<u>Relief Requested</u>

6. EY LLP asks that the Court enter an order allowing on a final basis EY LLP's compensation for professional services performed by EY LLP during the Final Compensation Period in the amount of \$161,732.90.

Background

7. On February 14, 2023 (the "<u>Petition Date</u>"), the Debtors each filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. Prior to the Effective Date, the Debtors managed and operated their businesses as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No trustee or examiner has been requested in these chapter 11 cases, and no committee has been appointed.

8. On March 9, 2023, the Debtors filed the Debtors' Application for Entry of an Order (I) Authorizing the Retention and Employment of Ernst & Young LLP as Debtors' Valuation, Financial Accounting Advisory, Investigative, and Tax Services Provider Effective as of February 14, 2023, and (II) Granting Related Relief [Docket No. 296] (the "Retention Application").

9. On March 22, 2023, the Court entered the Order (I) Authorizing the Retention and Employment of Ernst & Young LLP as Debtors' Valuation, Financial Accounting Advisory, Investigative, and Tax Services Provider Effective as of February 14, 2023 [Docket No. 347] (the "Retention Order").

10. Pursuant to the Retention Order, EY LLP is authorized to be compensated under the terms set forth in the Engagement Letters between the Debtors and EY LLP, and to be reimbursed for actual and necessary out-of-pocket expenses.

11. On March 22, 2023 (the "<u>Confirmation Date</u>"), the Court entered an order [Docket No. 350] (the "<u>Confirmation Order</u>") approving the *Disclosure Statement Relating to the Joint Prepackaged Plan of Reorganization of Avaya Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 51] and confirming the Plan.

12. The Effective Date of the Plan occurred on May 1, 2023 [Docket No. 385]. Pursuant to the terms of the Confirmation Order and the Plan, all requests for payment of

Professional Fee Claims (as defined in the Plan) must be filed within forty-five (45) days of the Effective Date.

Compensation Paid and Its Source

13. All services for which EY LLP requests compensation were performed for or on behalf of the Debtors. EY LLP has received no payment and no promises for payment from any source other than the Debtors for services rendered or to be rendered in any capacity in connection with the matters covered by this Application.

Summary of Services Provided During Final Compensation Period

14. As set forth in the Retention Application, EY LLP agreed to provide certain valuation, financial accounting advisory, and tax services (collectively, the "<u>Services</u>") to the Debtors in connection with these chapter 11 cases. A summary description of each of the Services is summarized below and fully described in the related Engagement Letters filed and approved in these cases.³

I. Valuation Services

ASC 350 and ASC 360

 a. EY LLP provided valuation services related to Accounting Standards Codification ("<u>ASC</u>") Topic 350 "Intangible – Goodwill and Other" and ASC Topic 360 "Impairment and Disposal of Long-Lived Assets", as well as valuation services related to the valuation of certain embedded derivatives, as of June 30, 2022, September 30, 2022, December 31, 2022, and March 31, 2023, to support Avaya's financial reporting requirements.

II. Tax Services

2022 Federal and State Tax Compliance

a. EY LLP completed Form 1065 Federal Partnership Income Tax Return and required state and local income tax returns (32 total) and extensions of time to

file state income tax returns for Avaya Management Limited Partnership ("<u>AMLP</u>") for the tax year ended September 30, 2022.

- b. EY LLP completed Form 1120F U.S. Income Tax Return of a Foreign Corporation and required state and local income tax returns (33 total) and extension of time to file state income tax returns for Avaya International Holdings Ltd. ("<u>AIHL</u>") for the tax year ended September 30, 2022.
- c. EY LLP analyzed and prepared applicable federal income tax withholding provisions of AMLP related to AIHL (*e.g.*, Forms 8804, 8805, and 8813).
- d. EY LLP prepared and filed (as required) FY 2022 federal and state estimated payment vouchers for AMLP and AIHL.

2022 Transfer Pricing Global Documentation

- a. EY LLP assisted the Debtors with preparing the local country transfer pricing documentation reports, update memoranda, and financial loan memoranda for FY 2022.
- b. EY LLP performed benchmarking searches for FY 2022 for certain comparable sets.
- c. EY LLP relied on the Comparable Uncontrolled Transaction ("<u>CUT</u>") license search performed in FY 2019 without financial updates for FY 2022 to benchmark the license of intangible property.
- d. EY LLP performed 13 yield curve searches for interest rate prices amongst third party lenders and borrowers for FY 2022.
- e. EY LLP prepared local country transfer pricing documentation reports and update memoranda for FY 2022, covering certain intercompany transactions.
- f. EY LLP prepared local country transfer pricing documentation reports for certain Avaya affiliates.
- g. EY LLP prepared update memoranda for certain Avaya affiliates.
- h. EY LLP prepared synthetic credit rating analysis for certain operating subsidiaries.
- i. EY LLP prepared financial loan memoranda for each of the 24 financial loans to be analyzed.

Routine On-Call Advisory

a. EY LLP provided to the Debtors routine tax advisory services and assistance concerning issues as requested by the Debtors when such projects are not

covered by a separate SOW and do not involve any significant tax planning or projects ("<u>On-Call Tax Advisory Services</u>").

b. Upon Debtors' written request, EY LLP provided one-off tax compliance services ("<u>On-Call Tax Compliance Services</u>").

III. Investigative Services

- a. EY LLP provided investigative services related to a privileged investigation performed by Avaya's outside counsel, Kirkland & Ellis LLP, at the direction of the Audit Committee.
- 15. The total time spent by EY LLP with respect to such services for the Debtors was

655.0 hours for the Final Compensation Period. The blended average hourly rate with respect to

such services was \$246.92 during the Final Compensation Period.

16. The supporting detail for this Fee Application is attached hereto as **Exhibit B**.

Exhibit B contains the daily time information for each EY LLP professional performing services

during the period from February 14, 2023, through March 22, 2023.

17. A proposed form of order granting the relief requested herein is attached hereto as

Exhibit C.

EY LLP's Requested Compensation Should Be Allowed

18. Section 330(a)(1) of the Bankruptcy Code provides, in relevant part, as follows:

(a) (1) After notice to the parties in interest and the United States Trustee and a hearing, and subject to sections 326, 328, and 329, the court may award to a \dots professional person employed under section 327 or 1103 –

(A) reasonable compensation for actual, necessary services rendered by the trustee, examiner, ombudsman, professional person, or attorney and by any paraprofessional person employed by any such person; and

(B) reimbursement for actual, necessary expenses.

19. Section 330 of the Bankruptcy Code prescribes the general standards for determining the reasonableness of the amount of compensation sought by a professional. *See* 3 Collier on Bankruptcy ¶ 331.03 at 331-12. Congress enacted section 330 of the

Bankruptcy Code to liberalize the practice of granting the allowance of compensation to professionals in bankruptcy cases in order to ensure that professionals be reasonably compensated and that future professionals not be deterred from taking bankruptcy cases due to a failure to pay adequate compensation. *See In re Ames Dep't Stores, Inc.*, 76 F.3d 66, 72 (2d Cir. 1996) (quoting *In re UNR Indus., Inc.*, 986 F.2d 207, 208-09 (7th Cir. 1993)).

20. Section 330(a) of the Bankruptcy Code provides for the compensation of reasonable and necessary services rendered by professionals based on the time, the nature, the extent and the value of such services, and the cost of comparable services other than in a case under the Bankruptcy Code. *See* 11 U.S.C. § 330. The test for determining necessity is objective; focusing on what services a reasonable professional would have performed under the same circumstances. *See, e.g., In re Angelika Films 57th, Inc.,* 227 B.R. 29, 42 (Bankr. S.D.N.Y. 1998). This test does not rely on hindsight to determine the ultimate success or failure of the professional's actions. *See id.; In re Keene Corp.,* 205 B.R. 690, 696 (Bankr. S.D.N.Y. 1997). Ultimately, if the services of a professional are reasonably likely to benefit the debtor's estate, they should be compensable. *See Angelika Films,* 227 B.R. at 42.

21. EY LLP respectfully submits that the compensation sought in this Application is necessary and reasonable. The services that EY LLP rendered to the Debtors during the Final Compensation Period required a high degree of professional competence, and EY LLP was required to expend substantial time and effort in providing those services. EY LLP performed efficiently, effectively and economically, and the results obtained have benefited the Debtors, their estates and creditors. Accordingly, EY LLP respectfully submits that approval of the compensation sought herein is warranted and should be approved.

22. Although every effort has been made to include all fees and expenses incurred in the Final Compensation Period, some fees and expenses might not be included in this First and

Final Fee Application due to delays caused by accounting and processing during the Final Compensation Period. EY LLP reserves the right to make further application to the Court for allowance of such fees and expenses not included herein.

Notice of this Application has been provided to the following parties or their respective counsel: (a) the U.S. Trustee for the Southern District of Texas; (b) the holders of the thirty largest unsecured claims against the Debtors (on a consolidated basis); (c) counsel to the Akin Ad Hoc Group; (d) counsel to the PW Ad Hoc Group; (e) the Prepetition ABL Agent and counsel thereto; (f) the Prepetition Term Loan Agent and counsel thereto; (g) the 6.125% Senior Secured First Lien Notes Trustee and counsel thereto; (h) the 8.00% Exchangeable Senior Secured Notes Trustee and counsel thereto; (i) the 2.25% Convertible Notes Trustee and counsel thereto; (j) the DIP Term Loan Agent and counsel thereto; (k) the DIP ABL Agent and counsel thereto; (l) the Office of the United States Attorney for the Southern District of Texas; (m) the state attorneys general for states in which the Debtors conduct business; (n) the Internal Revenue Service; (o) the Securities and Exchange Commission; (p) the Environmental Protection Agency; (q) other governmental agencies having a regulatory or statutory interest in these cases; and (r) any party that has requested notice pursuant to Bankruptcy Rule 2002. In light of the nature of the relief requested, no other or further notice is required.
