**ORDER GRANTING
FIRST AND FINAL FEE APPLICATION
OF PRICEWATERHOUSECOOPERS LLP, AS
AUDIT SERVICES PROVIDER TO THE DEBTORS,
FOR COMPENSATION AND REIMBURSEMENT OF EXPENSES
FOR THE PERIOD FROM FEBRUARY 14, 2023, THROUGH MARCH 22, 2023**

The Court has considered the *First and Final Fee Application of PricewaterhouseCoopers LLP, as Audit Services Provider to the Debtors, for Compensation and Reimbursement of Expenses for the Period from February 14, 2023, through March 22, 2023* (the “Application”)² filed by PricewaterhouseCoopers LLP (the “Applicant”). The Court orders:

1. Applicant is allowed compensation and reimbursement of expenses in the amount of \$764,653.72 for the period set forth in the Application.
2. The compensation and reimbursement of expenses allowed in this Order are approved on a final basis.
