Authorizing Assumption and Assignment of Executory Contracts and Unexpired Leases
to White Memorial Medical Center; Memorandum of Points and Authorities; Declaration

Howard M. Ehrenberg (the "Trustee"), the duly appointed, qualified, and acting chapter

Association, dba Beverly Hospital, a nonprofit public benefit corporation ("Beverly

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

- 1. The Motion is granted.
- 2. The executory contracts and unexpired leases set forth in the Motion shall be assumed and assigned to White Memorial Medical Center d/b/a Adventist Health White Memorial ("AHWM") according to the Cure Schedule (as defined in the Motion), provided, however, that the contracts defined as "3M Company/Purchase Order No. 074663" and "3M Health Information Systems, Inc./Request for Purchase Order" shall not be assumed and assigned to AHWM in accordance with AHWM's instructions (collectively, the "Assumed Contracts").

All counter-parties to Assumed Contracts shall cooperate with, and expeditiously execute and deliver upon, any reasonable request of AHWM, and shall not charge AHWM for, any instruments, applications, consents, or other documents that may be required or requested by any governmental unit or other public or quasi-public authority or other party to effectuate the applicable transfers in connection with the assumption and assignment of the Assumed Contracts to AHWM.
