1 The Court, having considered the “Second Stipulation to Continue Hearing
2 On Multiple Interim Fee Applications” (the “Stipulation”)² [Dkt. #910] entered into by and
3 between Howard M. Ehrenberg (the “Trustee”), the duly appointed, qualified, and acting
4 chapter 11 trustee for the estates of the jointly administered debtors Beverly Community
5 Hospital Association, dba Beverly Hospital, a nonprofit public benefit corporation
6 (“Beverly Community”), Montebello Community Health Services, Inc. (“Montebello
7 Health”), and Beverly Hospital Foundation (“Beverly Foundation”) (collectively and
8 interchangeably, the “Debtor” or “Debtors”), on the one hand, and U.S. Bank Trust
9 Company, National Association, as Master Trustee (“Master Trustee”), Triple P RTS, LLC
10 and Triple P Securities, LLC (collectively “TPS”), Sheppard Mullin Richter & Hampton,
11 LLP (“SMRH”), Dentons US LLP (“Dentons”), Sills Cummis & Gross PC (“Sills”),
12 Province, LLC (“Province”), Orrick, Herrington & Sutcliffe LLP (“Orrick”), and Colliers
13 International Greater Los Angeles (“Collier”), on the other hand, and for good cause
14 appearing therefor,

15 **IT IS HEREBY, ORDERED, ADJUDGED, AND DECREED** as follows:

- 16 1. The Stipulation is approved.
- 17 2. The hearing on the Fee Applications and the TPS Application (as
18 those terms are defined in the Stipulation) are hereby continued to May 8, 2024 at 10:00
19 a.m.
- 20 3. Objections to the Fee Applications must be filed on or before March
21 27, 2024.
- 22 4. Replies to the Objections must be filed on or before April 24, 2024.
