1. I am a Partner of Ernst & Young LLP ("<u>EY LLP</u>"). I submit this Supplemental

Declaration on behalf of EY LLP as a supplement to my original declaration that was filed on July 20, 2020 (the "<u>Ficks Retention Declaration</u>") in support of the application of the abovecaptioned debtors to retain and employ EY LLP as their financial and tax advisor effective as of July 20, 2020.

2. The facts set forth in this Supplemental Declaration in support of the *Debtors*'

Application for Authority to Retain and Employ Ernst & Young LLP as Financial and Tax Advisor to the Debtors Effective as to the Petition Date [Docket No. 42] (the "<u>Application</u>")¹ are based upon my personal knowledge, upon information and belief, and upon client-matter records

kept in the ordinary course of business that were reviewed by me or other employees of EY LLP under my supervision.

3. After the Application was filed, EY LLP continued its search of certain databases to determine whether it has in the recent past provided or is currently providing services to certain Parties in Interest, including those for which EY LLP had not obtained connections check results by the time the Application was filed (collectively, the "<u>Outstanding Parties in Interest</u>"). To the extent that this research has indicated that EY LLP has in the recent past, or currently has, a client relationship with the Outstanding Parties in Interest in matters unrelated to these chapter 11 cases, it is so indicated on Exhibit A to this Supplemental Declaration.
