1. <u>Schedules and Global Notes</u>. On August 23, 2020, Briggs & Stratton Corporation and its debtor affiliates, as debtors and debtors in possession (collectively, the "**Debtors**"), filed their respective Schedules of Assets and Liabilities, Statements of Financial Affairs and Global Notes and Statements of Limitations, Methodology and Disclaimers Regarding the Debtors' Schedules and Statements of Financial Affairs [Docket Nos. 555–559] (each, a "**Schedule**" and, collectively, the "**Schedules**").¹

2. <u>Amendments to Schedule E/F of Schedules of Certain Debtors</u>. Pursuant to Rule 1009(a) of the Federal Rules of Bankruptcy Procedure and Rule 1009(A) of the Local Rules of Bankruptcy Procedure of the United States Bankruptcy Court for the Eastern District of Missouri, annexed hereto as **Exhibits A**, **B**, **C** and **D** are schedules of claims amended respectively by Briggs & Stratton Corporation, Billy Goat Industries, Inc., Briggs & Stratton International, Inc. and Briggs & Stratton Tech, LLC on Schedule E/F of the Schedules (each, an "Amendment" and, collectively, the "Amendments"). A copy of the full Schedule E/F for each of the aforementioned

Schedule E/F of the Schedules of each of the aforementioned Debtors are unaltered with respect to all other claims, executory contracts or unexpired leases previously included therein of parties that are not listed on Exhibits A, B, C and D.

Nothing contained in this notice shall preclude the Debtors from (a) objecting to any claim, whether scheduled or filed, on any and all grounds, or (b) filing additional amendments to the Schedules, including Schedule E/F of the Schedules of each of the aforementioned Debtors.
