Resolving the Objection

2. <u>Parties Required to File a Response</u>. If you disagree with the Objection filed with respect to any of your claims, you may file a response (each, a "**Response**") with the Court in accordance with the procedures described below and appear at the Hearing (as defined herein).

3. <u>Response Contents</u>. Each Response should contain the following (at a

minimum):

- a. a caption stating the name of the Court, the name of the Debtors, the case number, and the Objection and claim or claims within the Objection to which the Response is directed;
- b. a concise statement setting forth the reasons why the Court should not grant the objection with respect to such claim(s), including the factual and legal bases upon which you rely in opposing the Objection;
- c. copies of documentation or other evidence of your claim (not previously filed with proof of such claim) on which your Response is based (excluding confidential, proprietary, or other protected information, copies of which must be provided to the counsel to the Plan Administrator, subject to appropriate confidentiality constraints, if any); and
- d. the following contact information:
 - (i) your name, address, telephone number, and email address or the name, address, telephone number, and email address of your attorney or designated representative to whom the attorneys for the Plan Administrator should serve a reply to the Response, if any; or
 - (ii) the name, address, telephone number, and email address of the party with authority to reconcile, settle, or otherwise resolve the objection on your behalf (to the extent different from the information detailed in paragraph 3(d)(i) above).

4. <u>Response Deadline</u>. Your Response must be filed with the Court and served so as to be *actually received* by 11:59 p.m. (Central Time) on May 5, 2021 (the "Response Deadline").

5. <u>Failure to Respond</u>. A Response that is not filed and served in accordance with the procedures set forth herein may not be considered by the Court at the Hearing. Absent an agreement with the Plan Administrator resolving the Objection to a claim, failure to timely file and serve a Response as set forth herein and appear at the Hearing may result in the Court granting the Objection without further notice or hearing. Upon entry of an order, you will be served with a notice of entry, and a copy, of the order.

Hearing on the Objection

6. <u>Date, Time, and Location</u>. If necessary, a hearing (the "Hearing") on the Objection will be held on May 12, 2021 at 10:00 a.m. (Central Time) in the United States Bankruptcy Court for the Eastern District of Missouri, 5th Floor, North Courtroom, Thomas F. Eagleton United States Courthouse, 111 South Tenth Street, St. Louis, Missouri. Such Hearing may be adjourned from time to time in these chapter 11 cases in the Plan Administrator's sole discretion. You must attend the Hearing if you disagree with the Objection and have filed a Response. If you file a Response in accordance with the response procedures herein, but such Response is not resolved prior to the Hearing, and you appear at the Hearing, the Objection may be heard at the Hearing or adjourned to a subsequent hearing in the Plan Administrator's sole discretion. If a subsequent hearing is determined to be necessary, the Plan Administrator will file with the Court and serve you with a notice of the subsequent hearing (the date of which will be determined in consultation with the affected claimant(s)).

of this omnibus objection to claims (the "Objection") filed by individual employees for their

respective benefits under the Briggs & Stratton Corporation Pension Plan (the "Qualified Pension Plan"), which covers certain of the Company's active and former U.S. Employees, including Union Employees. The Qualified Pension Plan was terminated by agreement with the Pension Benefit Guaranty Corporation (the "PBGC"), whose claims were allowed as part of the confirmed Plan. Accordingly, the Plan Administrator submits that the claims of the individual employees relating to the terminated Qualified Pension Plan are duplicative of the Allowed Claims of the PBGC (the "PBGC Claims"). The PBGC Claims consist of: (1) a claim for unfunded benefit liabilities in the amount of \$202,400,000.00 and (2) a claim for termination premiums with respect to the terminated Qualified Pension Plan in the amount of \$18,517,500.² In support of this Objection, attached hereto as <u>Exhibit B</u> is the *Declaration of Alan D. Halperin as Plan Administrator in Support of the Wind-Down Estates' Sixteenth Omnibus Objection to Claims on Grounds that such Claims are Duplicative (the "Halperin Claims Declaration")*.

Background

1. On July 20, 2020 (the "**Petition Date**"), the Debtors each commenced with this Court a voluntary case under title 11 of the United States Code (the "**Bankruptcy Code**"). The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

2. On August 5, 2020, the United States Trustee appointed an official committee of unsecured creditors (the "Creditors' Committee") in these chapter 11 cases

pursuant to section 1102 of the Bankruptcy Code. No trustee or examiner has been appointed in these chapter 11 cases. The Debtors' chapter 11 cases are being jointly administered for procedural purposes only pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the "**Bankruptcy Rules**") and Rule 1015(b) of the Local Rules of Bankruptcy Procedure for the Eastern District of Missouri (the "**Local Rules**").

3. On September 15, 2020, the Court entered an order authorizing the Debtors to sell substantially all of their assets³ to Bucephalus Buyer, LLC (the "**Purchaser**") and on September 21, 2020, the Debtors closed the Sale Transaction.⁴ On December 16, 2020, the Debtors filed the Plan, which was confirmed by the *Findings of Fact, Conclusions of Law, and Order Confirming the Plan* on December 18, 2020 [Docket No. 1485] (the "**Confirmation Order**").

4. The Effective Date of the Plan occurred on January 6, 2021 and the *Notice of Entry of Order Confirming the Plan and Occurrence of the Effective Date* [Docket No. 1538] was filed, at which time the Committee was relieved of its duties and the Plan Administrator took over the administration of the Wind-Down Estates in accordance with the Plan. The Wind-Down Estates continue to honor their post-closing sale obligations, wind down the estates, and otherwise work on concluding these chapter 11 cases.

5. On February 12, 2020, the Bankruptcy Court entered that certain Order Approving Claims Objection Procedures, Claims Hearing Procedures and Granting Related Relief [Docket No. 1614] (the "**Omnibus Procedures Order**"), which, among other things, increased

the number of claims authorized to be filed in an omnibus claim objection such as this Objection to three hundred fifty (350) Claims.

6. Pursuant to the global settlement by which by which the Creditors' Committee and the PBGC consented to the Sale Transaction to the extent it was consummated before September 27, 2020 (the "Global Settlement"), as incorporated in the Order (I) Authorizing the Sale of the Assets and Equity Interest to the Purchaser Free and Clear of Liens, Claims, Interests, and Encumbrances; (II) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases; and (III) Granting Related Relief [Docket No. 898] (the "Sale Order"), the PBGC has an Allowed General Unsecured Claim (which was estimated to be no more than \$225 million against each Debtor and has been subsequently fixed, as described above).

Jurisdiction

7. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

Relief Requested

8. Pursuant to section 502(b) of title 11 of the United States Code (the "**Bankruptcy Code**"), Rule 3007 of the Federal Rules of Bankruptcy Procedure (the "**Bankruptcy Rules**"), and Rule 3007(C) of the Local Rules of Bankruptcy Procedure of the United States Bankruptcy Court for the Eastern District of Missouri (the "**Local Rules**") the Plan Administrator respectfully requests entry of an order (the "**Proposed Order**")⁵ disallowing the claims listed on **Exhibit A** attached hereto (the "**Duplicate Claims**").

Claims Reconciliation

9. On August 23, 2020, the Debtors filed their schedules of assets, liabilities, current income, expenditures, executory contracts, and unexpired leases and statements of financial affairs, as required by section 521 of the Bankruptcy Code [Docket Nos. 555–559] (collectively, the "**Schedules**").

10. On August 24, 2020, the Court entered an order [Docket No. 564] (the "**Bar Date Order**"), which, among other things, established (a) October 7, 2020 as the deadline for all non-governmental entities holding or wishing to assert a "claim" (as defined in section 101(5) of the Bankruptcy Code) against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing (the "General Bar Date"), and (b) January 19, 2021 as the deadline for all governmental entities holding or wishing to assert a "claim" against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing.

11. As of the date hereof, approximately 2,800 proofs of claim (the "**Proofs of Claim**") have been filed against the Debtors. The Plan Administrator and his advisors have been working diligently to review these Proofs of Claim, including any supporting documentation filed therewith. For the reasons set forth below, and based on their review to date, the Plan Administrator has determined that the claims objected to herein should be disallowed.

12. As set forth in the Halperin Claims Declaration, the Plan Administrator and his professionals have examined each Duplicate Claim, all documentation provided by the claimant with respect to each Duplicate Claim, and the Debtors' respective books and records, and have determined in each case the Duplicate Claims are claims that should be disallowed on the basis that each Duplicate Claim is duplicative of the Allowed Claims of the PBGC.

Relief Requested Should Be Granted

13. Pursuant to section 502 of the Bankruptcy Code, "[a] claim or interest, proof of which is filed under section 501 of [the Bankruptcy Code], is deemed allowed, unless a party in interest . . . objects." 11 U.S.C. § 502(a). Bankruptcy Rule 3001(f) provides that a properly executed and filed proof of claim constitutes *prima facie* evidence of the validity and amount of the claim under section 502(a) of the Bankruptcy Code. FED. R. BANKR. P. 3001(f). The act of filing an objection alone "does not deprive the proof of claim of presumptive validity unless the objection is supported by substantial evidence." In re Austin, 538 B.R. 543, 545 (Bankr. E.D. Mo. 2015) (citing In re McDaniel, 264 B.R. 531, 533 (B.A.P. 8th Cir. 2001)). If the objection presents evidence "rebutting the claim," then "the claimant must produce additional evidence to prove the validity of the claim by a preponderance of the evidence." In re Austin, 538 B.R. at 545 (citing In re Gran, 964 F.2d 822, 827 (8th Cir. 1992); see also In re Peabody Energy Corp., Case No. 16-42529 (BSS), 2017 WL 4570700, at *7 (Bankr. E.D. Mo. Oct. 12, 2017); In re Seagraves, Case No. 12-49433 (BSS), 2015 WL 2026707, at *2 (Bankr. E.D. Mo. Apr. 30, 2015); Dove-Nation v. eCast Settlement Corp. (In re Dove-Nation), 318 B.R. 147, 152 (B.A.P. 8th Cir. 2004) (citing In re Innovative Software Designs, Inc., 253 B.R. 40, 44 (B.A.P. 8th Cir. 2000)).

14. The claims in the attached <u>**Exhibit** A</u> are exclusively comprised of Unsecured Claims filed by individual employees related to the Qualified Pension Plan.⁶

15. The PBGC has filed ten separate claims in connection with its control over the Qualified Pension Plan pursuant to 29 U.S.C. §§ 1307 & 1362, i.e. the Employee Retirement

⁶ Twenty-four (24) of the claims on Exhibit A were also filed after the applicable bar date. Income Security Act provisions on pension plan premium payments and termination liability. The PBGC Claims have been allowed pursuant to the Plan: Briggs & Stratton Corporation, claim no. 983 in the amount of \$18,517,500.00 and claim no. 984 in the amount of \$202,400,000.00; Billy Goat Industries, Inc., claim no. 104 in the amount of \$18,517,500.00 and claim no. 105 in the amount of \$202,400,000.00; Allmand Bros., Inc., claim no. 58 in the amount of \$18,517,500.00 and claim no. 59 in the amount of \$202,400,000.00; Briggs & Stratton International, Inc., claim no. 20 in the amount of \$18,517,500.00 and claim no. 21 in the amount of \$202,400,000.00; Briggs & Stratton Tech, LLC, claim no. 19 in the amount of \$18,517,500.00 and claim no. 20 in the amount of \$202,400,000.00 (the "**PBGC Allowed Claims**").

16. Under the Plan, the PBGC Allowed Claims have been allowed. All of the Claims that are subject to this Objection were filed by individual employees for their respective benefits under the Pension Plans, which represent the same liabilities that were resolved by the Global Settlement. The Allowed PBGC Claims are on account of unpaid pension plan premiums and termination liability under the Pension Plans. If the Claims are not disallowed, it will undermine the PBGC Settlement and duplicate all or a portion of the PBGC Allowed Claims. As such, the Plan Administrator seeks to disallow the Claims as duplicative of the PBGC Allowed Claims pursuant to §§ 105(a) and 502 of the Bankruptcy Code, Bankruptcy Rules 3007 and 9014, and Local Rule 3007-1.

17. As the PBGC Allowed Claims have been allowed under the Plan, the claim by individual employees identified in the attached **Exhibit** \mathbf{A} are duplicative and should be disallowed.

18. Nothing contained herein is intended to be or shall be deemed as (i) an admission as to the validity of any claim against the Debtors or the Wind-Down Estates, (ii) a

DECLARATION OF ALAN D. HALPERIN IN SUPPORT OF PLAN ADMINISTRATOR'S SIXTEENTH OMNIBUS OBJECTION TO CLAIMS ON GROUNDS THAT SUCH CLAIMS ARE DUPLICATIVE (PENSION)

I, Alan D. Halperin, solely in my capacity as Plan Administrator in the abovereferenced cases, make this declaration (the "**Declaration**") under 28 U.S.C. § 1746:

1. I am the Plan Administrator of the Wind-Down Estates of Briggs & Stratton Corporation and its affiliated debtors (the "**Debtors**").¹

2. Except as otherwise indicated, this Declaration is based upon my personal knowledge; my review of relevant documents (including the Schedules, the Duplicate Claims, and the Objection); information provided to me by: (i) a former officer of the Debtors with whom the Wind-Down Estates have entered into a consulting agreement, (ii) former employees that were transferred to the Purchaser and who provide claims reconciliation services to the Debtors pursuant to a transition services agreement with the Purchaser, (iii) the Debtors' legal and financial advisors, and/or (iv) my legal counsel and such professionals working directly with me or under my supervision, direction, or control; or my opinion, based upon my experience, knowledge, and information concerning the Debtors' operations. If called upon to testify, I would testify competently to the facts set forth herein. I am authorized to submit this Declaration on behalf of

the Wind-Down Estates, in support of the *Plan Administrator's Sixteenth Omnibus Objection to Claims on Grounds that Such Claims Are Duplicative (Pension)* (the "**Objection**").

3. To the best of my knowledge, information, and belief, the assertions made in the Objection are accurate. I can confirm that the Plan Administrator's advisors have examined each Duplicate Claim, all documentation provided by the claimant with respect to each Duplicate Claim, the Debtors' respective books and records, and the Schedules, and have determined that each Duplicate Claim is a claim that should be disallowed on the basis that each Duplicate Claim seeks payment of a debt for which the specified Debtor has already allowed a claim in the name of and for the benefit of the PBGC. As such, the Duplicate Claims should be disallowed.

4. Failure to disallow the Duplicate Claims would entitle such individual employees to recoveries on account of such claims to which such employees are not entitled as, the PBGC has taken over the Qualified Pension Plan and the PBGC Allowed Claims have been allowed. All of the Claims were filed by individual employees for their respective benefits under the Pension Plans, which represent the same liabilities that were resolved by the Global Settlement. The Allowed PBGC Claims are on account of unpaid pension plan premiums and termination liability. Thus, if the Claims are not disallowed and expunged, they will contravene the PBGC Settlement and duplicate a portion of the PBGC Allowed Claims. To that end, these Duplicate Claims will, then, dilute the ultimate recovery of other claims. As such, I believe that disallowance of the Duplicate Claims is appropriate.

5. I declare under penalty of perjury that, to the best of my knowledge and after reasonable inquiry, the foregoing is true and correct.
