ORDER VACATING ORDER SUSTAINING THE PLAN ADMINISTRATOR'S FIFTEENTH OMNIBUS OBJECTION TO CLAIMS ON GROUNDS OF NO LIABILITY IN PART ONLY WITH RESPECT TO CLAIMS OF PATRICK C. JOYCE, III AND RESCHEDULING HEARING ON FIFTEENTH OMNIBUS OBJECTION TO CLAIMS OF PATRICK C. JOYCE, III

Alan D. Halperin as Plan Administrator (Plan Administrator) under the Amended Joint Chapter 11 Plan of Briggs & Stratton Corporation and its Affiliated Debtors, dated November 9, 2020, filed his Fifteenth Omnibus Objection to Claims on Grounds of No Liability (Fifteenth Omnibus Objection). Patrick C. Joyce, III filed a document in response to the Fifteenth Omnibus Objection. After a hearing, on May 12, 2021 an Order Sustaining the Plan Administrator's Fifteenth Omnibus Objection to Claims on Grounds of No Liability (Fifteenth Omnibus Order) was entered, sustaining the Fifteenth Omnibus Objection in that claims, including claims 2311 and 672 filed by Patrick C. Joyce, III in the case of Briggs & Stratton Corporation, Case No. 20-43597 (Joyce Claims), were disallowed. On May 17, 2021, Mr. Joyce filed a document titled "Motion for Sanctions of Counsel." Upon careful consideration and on this Court's own motion, it is hereby

ORDERED that the Fifteenth Omnibus Order is vacated in part <u>only</u> with respect to the Joyce Claims and not with respect to any other claims disallowed by that order. It is further

ORDERED that the hearing on the Fifteenth Omnibus Objection as it pertains to the Joyce Claims is rescheduled for <u>June 10, 2021, at 2:00 p.m</u>., in the United States Bankruptcy Court, Eastern District of Missouri, United States Courthouse, Thomas F.
