If necessary, a hearing (the "Hearing") on the Objection will be held on August 5, 2021 at 2:00 p.m. (Central Time) in the United States Bankruptcy Court for the Eastern District of Missouri, 5th Floor, North Courtroom, Thomas F. Eagleton United States Courthouse, 111 South Tenth Street, St. Louis, Missouri. Such Hearing may be adjourned from time to time in these chapter 11 cases in the Plan Administrator's sole discretion. You must attend the Hearing if you disagree with the response procedures herein, but such Response. If you file a Response in accordance with the response procedures herein, but such Response is not resolved prior to the Hearing, and you appear at the Hearing, the Objection may be heard at the Hearing or adjourned to a subsequent hearing in the Plan Administrator's sole discretion. support of this omnibus objection to claims (the "**Objection**") on grounds that such claims (the "**SERP Claims**") were fixed upon entry of the Confirmation Order in accordance with individual actuarial calculations performed by Mercer Human Resource ("**Mercer**"), the actuary for the Supplemental Executive Retirement Plan and the Supplemental Employee Retirement Plan (the "**SERPs**"), using each individual's participant data and the plan assumptions, which SERP Claims were estimated in the Debtors' Disclosure Statement to be in the aggregate approximately \$78.8 million. As the Plan provided that each of the SERP Claims was to be allowed in the amount determined by Mercer irrespective of whether a SERP Claimant filed (or was scheduled for) a claim, the report prepared by Mercer (the "**Mercer Report**") as to such SERP Claims is binding on the Wind-Down Estates and the claims register should be amended to reflect the Mercer Report in every respect.

Accordingly, attached hereto as **Exhibit A-1** are those claims where the Mercer valuation is less than the individual's asserted claim amount and the Plan Administrator seeks to reduce the claim. **Exhibit A-2** are those claims where the Mercer valuation is greater than the individual's asserted claim amount. **Exhibit A-3** are those claims where individuals were scheduled for a claim (marked as contingent, unliquidated, disputed) but failed to file a proof of claim. For the avoidance of doubt, the Exhibit A-3 claims are to be allowed in accordance with the Mercer valuation, pursuant to the Plan. **Exhibit A-4** are those claims where individuals were neither scheduled for a claim nor did they file a proof of claim, yet the Mercer valuation indicates that a claim is merited. Again, the Exhibit A-4 claims are to be allowed in accordance with the Mercer valuation, pursuant to the Plan.

Objection to Claims on Grounds that Such Claims Were Fixed by the Confirmation Order (SERP) (the "Halperin Claims Declaration"):

Background

1. On July 20, 2020 (the "**Petition Date**"), the Debtors each commenced with this Court a voluntary case under title 11 of the United States Code (the "**Bankruptcy Code**"). The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

2. On August 5, 2020, the United States Trustee appointed an official committee of unsecured creditors (the "**Creditors' Committee**") in these chapter 11 cases pursuant to section 1102 of the Bankruptcy Code. No trustee or examiner has been appointed in these chapter 11 cases. The Debtors' chapter 11 cases are being jointly administered for procedural purposes only pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the "**Bankruptcy Rules**") and Rule 1015(b) of the Local Rules of Bankruptcy Procedure for the Eastern District of Missouri (the "**Local Rules**").

3. On September 15, 2020, the Court entered an order authorizing the Debtors to sell substantially all of their assets² to Bucephalus Buyer, LLC (the "**Purchaser**") and on September 21, 2020, the Debtors closed the Sale Transaction.³ On December 16, 2020, the Debtors filed the Plan, which was confirmed by the *Findings of Fact, Conclusions of Law, and Order Confirming the Plan* on December 18, 2020 [Docket No. 1485] (the "**Confirmation Order**").

4. The Effective Date of the Plan occurred on January 6, 2021 and the *Notice of Entry of Order Confirming the Plan and Occurrence of the Effective Date* [Docket No. 1538] was filed, at which time the Creditors' Committee was relieved of its duties and the Plan Administrator took over the administration of the Wind-Down Estates in accordance with the Plan. The Wind-Down Estates continue to honor their post-closing sale obligations, wind down the estates, and otherwise work on concluding these chapter 11 cases.

5. On February 12, 2020, the Bankruptcy Court entered that certain Order Approving Claims Objection Procedures, Claims Hearing Procedures and Granting Related Relief [Docket No. 1614] (the "**Omnibus Procedures Order**"), which, among other things, increased the number of claims authorized to be filed in an omnibus claim objection such as this Objection to three hundred fifty (350) Claims.

Jurisdiction

The Court has jurisdiction to consider this matter pursuant to 28 U.S.C.
§§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper
before the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

Relief Requested

7. Pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rule 3007(d)(5), and Local Rule 3007(C), the Plan Administrator respectfully requests entry of an order (the "**Proposed Order**"),⁴ amending the SERP Claims listed on **Exhibit A**.

Claims Reconciliation

8. On August 23, 2020, the Debtors filed their schedules of assets, liabilities, current income, expenditures, executory contracts, and unexpired leases and statements of

financial affairs, as required by section 521 of the Bankruptcy Code [Docket Nos. 555–559] (collectively, the "**Schedules**").

9. On August 24, 2020, the Court entered an order [Docket No. 564] (the "**Bar Date Order**"), which, among other things, established (a) October 7, 2020 as the deadline for all non-governmental entities holding or wishing to assert a "claim" (as defined in section 101(5) of the Bankruptcy Code) against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing (the "**General Bar Date**"), and (b) January 19, 2021 as the deadline for all governmental entities holding or wishing to assert a "claim" against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing.

10. As of the date hereof, approximately 2,950 proofs of claim (the "**Proofs of Claim**") have been filed against the Debtors. The Plan Administrator and his advisors have been working diligently to review these Proofs of Claim, including any supporting documentation filed therewith. For the reasons set forth below, and based on their review to date, the Plan Administrator has determined that the claims objected to herein should be modified.

11. As set forth in the Halperin Claims Declaration, the Plan Administrator and his professionals have examined each SERP Claim and conformed each to the Mercer Report. Accordingly, each such corresponding proof of claim should be treated as follows: <u>Exhibit A-1</u> identifies those claims where the Mercer valuation is less than the individual's asserted claim amount and the Plan Administrator seeks to reduce the claim. <u>Exhibit A-2</u> identifies those claims where the Mercer valuation is greater than the individual's asserted claim amount. <u>Exhibit A-3</u> identifies those claims where individuals were scheduled for a claim (marked as contingent, unliquidated, disputed) but failed to file a proof of claim. For the avoidance of doubt, the Exhibit A-3 claims are to be allowed in accordance with the Mercer

valuation, pursuant to the Plan. <u>Exhibit A-4</u> identifies those claims where individuals were neither scheduled for a claim nor did they file a proof of claim, yet the Mercer valuation indicates that a claim is merited. Again, the Exhibit A-4 claims are to be allowed in accordance with the Mercer valuation, pursuant to the Plan.

<u>Relief Requested Should Be Granted</u>

12. Pursuant to section 502 of the Bankruptcy Code, "[a] claim or interest, proof of which is filed under section 501 of [the Bankruptcy Code], is deemed allowed, unless a party in interest . . . objects." 11 U.S.C. § 502(a). Bankruptcy Rule 3001(f) provides that a properly executed and filed proof of claim constitutes *prima facie* evidence of the validity and amount of the claim under section 502(a) of the Bankruptcy Code. FED. R. BANKR. P. 3001(f). The act of filing an objection alone "does not deprive the proof of claim of presumptive validity unless the objection is supported by substantial evidence." In re Austin, 538 B.R. 543, 545 (Bankr. E.D. Mo. 2015) (citing In re McDaniel, 264 B.R. 531, 533 (B.A.P. 8th Cir. 2001)). If the objection presents evidence "rebutting the claim," then "the claimant must produce additional evidence to prove the validity of the claim by a preponderance of the evidence." In re Austin, 538 B.R. at 545 (citing In re Gran, 964 F.2d 822, 827 (8th Cir. 1992); see also In re Peabody Energy Corp., Case No. 16-42529 (BSS), 2017 WL 4570700, at *7 (Bankr. E.D. Mo. Oct. 12, 2017); In re Seagraves, Case No. 12-49433 (BSS), 2015 WL 2026707, at *2 (Bankr. E.D. Mo. Apr. 30, 2015); Dove-Nation v. eCast Settlement Corp. (In re Dove-Nation), 318 B.R. 147, 152 (B.A.P. 8th Cir. 2004) (citing In re Innovative Software Designs, Inc., 253 B.R. 40, 44 (B.A.P. 8th Cir. 2000)).

13. The claims in the attached <u>**Exhibit** A</u> have all been identified as claims associated with the Debtors' SERPs, for which each SERP Claim was evaluated by the Debtors' actuary, Mercer. The Debtors agreed to be bound by the Mercer Report as to each of the SERP

Claims, irrespective of whether the ultimate claimant properly and timely filed a proof of claim. Thus, the Plan Administrator seeks to reconcile each of the SERP Claims with a valuation consistent with the Mercer Report.

Reservation of Rights

14. Nothing contained herein is intended to be or shall be deemed as (i) an admission as to the validity of any claim against the Debtors or the Wind-Down Estates, (ii) a waiver or limitation of rights to dispute the amount of, basis for, or validity of any claim, (iii) a waiver of rights under the Bankruptcy Code or any other applicable nonbankruptcy law, (iv) an agreement or obligation to pay any claims, (v) a waiver of any claims or causes of action which may exist against any creditor or interest holder, or (vi) an approval, assumption, adoption, or rejection of any agreement, contract, lease, program, or policy under section 365 of the Bankruptcy Code.

<u>Notice</u>

15. Notice of this Objection will be provided to (i) the Office of the United States Trustee for the Eastern District of Missouri (Attn: Sirena Wilson, Esq.); (ii) the Claimant; (iii) any other party that has requested notice pursuant to Bankruptcy Rule 2002; and (iv) any other party entitled to notice pursuant to the Omnibus Procedures Order (collectively, the "**Notice Parties**").

No Previous Request

16. No previous request for the relief sought herein has been made by the Debtors or the Plan Administrator to this or any other court.
