SUMMARY OF PROFESSIONAL SERVICES RENDERED AND EXPENSES INCURRED

- 8. KAR seeks allowance of compensation of professional services rendered to the Debtor during the Compensation Period in the amount of \$54,395.00. In addition, KAR seeks approval for reimbursement of expenses incurred in connection with the rendition of its services in the aggregate amount of \$79.25.
- 9. During the Compensation Period, KAR attorneys and paraprofessionals expended a total of 94.6 hours for which compensation is requested. The fees charged by KAR in this proceeding are billed in accordance with its existing billing rates and procedures in effect during the Compensation Period.
- 10. The following summary highlights the major areas in which KAR rendered services during the Compensation Period. The summary is organized by project category. A summary chart setting forth the number of hours spent and the amount of compensation requested for each project category is attached as Exhibit B and a summary chart setting forth the amount of expenses requested by KAR in this Application is attached as Exhibit C. The full breadth of KAR 's services performed for the period May 19. 2025 through and including October 23, 2025 is reflected in the time records.

- 11. As described in more detail below, during the Compensation Period KAR advised the Debtor on a broad range of issues, including but not limited to a motion to dismiss the case, complying with the U.S. Trustee's request and general administration.
- 12. With respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field; and
