(the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and Rules 2016-1 and -3 of the Local Rules of the United States Bankruptcy Court District of New Jersey (the "Local Rules") and in accordance with the Administrative Fee Order Establishing Procedures for the Allowance and Payment of Interim Compensation and Reimbursement of Expenses of Professionals Retained by Order of This Court [Docket No. 324] (the "Admin Fee Order"), the Order (I) Approving the Disclosure Statement, (II) Confirming the Amended Joint Chapter 11 Plan of CBRM Realty Inc. and Certain of Its Debtor Affiliates (With Technical Modifications), and (III) Granting Related Relief [Docket No. 525] (the "KH Confirmation Order"), the Amended Joint Chapter 11 Plan of CBRM Realty Inc. and Certain of Its Debtor Affiliates (With Technical Modifications) (as may be modified, amended, or supplemented from time to time, the "KH Plan"), the Revised Order (I) Approving the Disclosure Statement, (II) Confirming the Modified Joint Chapter 11 Plan of Crown Capital Holdings LLC and Certain of Its Debtor Affiliates, and (III) Granting Related Relief [Docket No. 653] (the "NOLA Confirmation Order" and, together with the KH Confirmation Order, the "Confirmation Orders"), and the Modified Joint Chapter 11 Plan of Crown Capital Holdings LLC and Certain of Its Debtor Affiliates (as may be modified, amended, or supplemented from time to time, the "NOLA Plan" and, together with the KH Plan, the "Plans"), White & Case, as counsel to the debtors and debtors in possession (the "Debtors") in the above-captioned cases (the

"Chapter 11 Cases"), hereby submits its final application (the "Application") for the period May 19, 2025 through October 23, 2025 (the "Application Period"), requesting that the Court enter an order (the "Order"), substantially in the form submitted herewith, (a) allowing reasonable compensation for legal services rendered and reimbursement of actual, reasonable and necessary expenses incurred on behalf of the Debtors for the Application Period, in the amount of \$6,091,471.22, consisting of \$6,023,906.00 in fees and \$67,565.22 in expenses; (b) ordering the Debtors to pay such allowed amounts to the extent they have not already been paid; and (c) granting such other and further relief as is just and proper. In support of the Application, White & Case respectfully represents as follows:

### **BACKGROUND**

- 1. On May 19, 2025 (the "**Petition Date**"), each Debtor (except Laguna Reserve Apts Investor LLC) filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. On August 17, 2025, Laguna Reserve Apts Investor LLC filed a voluntary petition with this Court under chapter 11 of the Bankruptcy Code. These Chapter 11 Cases are being jointly administered pursuant to Bankruptcy Rule 1015(b). No trustee or examiner has been appointed in these Chapter 11 Cases and no official committees have been appointed or designated.
- 2. Additional factual information regarding the Debtors' business, their capital structure, and the circumstances leading to these chapter 11 filings is contained in the First Day Declaration [Docket No. 21].
- 3. On June 18, 2025, the Debtors filed their application to employ and retain White & Case as counsel (the "**Retention Application**"). [Docket No. 173]. On June 25, 2025, declarations by Elizabeth LaPuma and Gregory F. Pesce in support of the application were filed. [Docket Nos. 208, 209]. Supplemental declarations by Gregory F. Pesce were also later filed. [Docket Nos. 291, 437].

- 4. On June 27, 2025, the Court entered an order approving the Debtors' employment and retention of White & Case (the "Retention Order"). [Docket No. 225]. The Retention Order authorizes the Debtors to compensate and reimburse White & Case in accordance with the terms and conditions set forth in the Retention Order for the services provided by White & Case to the Debtors.
- 5. White & Case has submitted fees and expenses in monthly fee statements under the Admin Fee Order covering the Application Period, summarized as follows:

- 6. While the above amounts for Approved Fees and Approved Expenses have been approved under the Admin Fee Order, not all such amounts have been paid to White & Case. As of the date hereof, fees and expenses of \$4,096,099.63 have been approved under the Admin Fee Order, fees and expenses of \$2,576,260.19 have been paid to White & Case, and fees and expenses of \$2,533,684.64 remain unpaid following approval under the Admin Fee Order due to a lack of available funding (not including the 20% holdback unpaid under the Admin Fee Order).
- 7. Debtors CBRM Realty Inc., Kelly Hamilton Apts MM LLC, and Kelly Hamilton Apts LLC (the "Kelly Hamilton Debtors") prepared and filed the KH Plan, which was later

confirmed by the KH Confirmation Order. Debtors Crown Capital Holdings LLC, RH New Orleans Holdings LLC, RH New Orleans Holdings MM LLC, Laguna Reserve Apts Investor LLC, RH Chenault Creek LLC, RH Copper Creek LLC, RH Lakewind East LLC, and RH Windrun LLC (the "NOLA Debtors") prepared and filed the NOLA Plan, which was later confirmed by the NOLA Confirmation Order.

- 8. Pursuant to the Confirmation Orders and Plans, White & Case is to file its final requests for payment of professional compensation and reimbursement of expenses no later than 45 days after their respective Effective Date.
  - 9. The Effective Date under the KH Plan occurred on November 12, 2025.
  - 10. The Effective Date under the NOLA Plan has not yet occurred.
- 11. By this Application, White & Case requests final approval of compensation earned, and expenses incurred, throughout the Application Period.

### JURISDICTION, VENUE, AND STATUTORY PREDICATES

12. This Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Standing Order of Reference to the Bankruptcy Court Under Title 11 of the United States District Court for the District of New Jersey*, dated July 23, 1984, and amended on September 18, 2012 (Simandle, C.J.). Consideration of this Application is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409. The statutory predicates for the relief sought herein are sections 327, 330, and 331 of the Bankruptcy Code, Rule 2016 of the Federal Rules of Bankruptcy Procedure and Local Bankruptcy Rules 2016-1 and 2016-3.

### SUMMARY OF SERVICES PERFORMED BY WHITE & CASE

13. The services performed by White & Case during the Application Period were categorized into twenty (20) project categories encompassing various aspects of these Chapter 11

Cases. White & Case attempted to place such services in the category that best fit same. However, because certain services may relate to more than one category, services pertaining to the same matter may be included in more than one category.

14. The following is a narrative summary of the services performed by White & Case within each project category to which White & Case professionals and paraprofessionals dedicated significant time (i.e., more than 20 hours during the Application Period).

### B01 Asset Sales: Kelly Hamilton: 294.2 Hours; \$395,341.74 Fees

15. During the Application Period, White & Case advised the Debtors with respect to all aspects of the Debtors' sale of the Kelly Hamilton property and related assets. This included review and negotiation of the sale and asset purchase agreements, drafting and revising bidding procedures, drafting and revising the related sale motion, supporting declarations, and proposed orders [Docket Nos. 281, 313, 314], preparing and updating nondisclosure agreements, and coordinating with multiple parties regarding sale strategy, auction processes, and regulatory compliance. The work also encompassed research on relevant legal precedents, preparation of supporting declarations, communication with brokers, government actors, and various stakeholders, and management of notices and filings related to the sale, auction, and assumption of executory contracts. These efforts culminated in the sale of the Kelly Hamilton property to 3650 SS1 PITTSBURGH LLC.

### B02 Automatic Stay Issues: 100.0 Hours; \$105,202.00 Fees

16. During the Application Period, White & Case advised the Debtors with respect to identifying, addressing, and preventing potential automatic stay violations in various contexts, primarily with respect to ongoing state court litigation. The services included extensive legal research on automatic stay issues and exemptions, drafting and revising violation letters and related correspondence, coordinating filings and notices of bankruptcy in multiple state court

actions (primarily in Louisiana and Pennsylvania), and communicating with local counsel, the Independent Fiduciary, and opposing parties. The team also managed litigation tracking, prepared and filed notices of appearance and indications of bankruptcy, and ensured proper service and compliance with relevant procedural rules, all aimed at protecting the properties of the Debtors' estates.

### **B04** Vendors, Taxes, Insurance and Business Operations Issues: 121.9 Hours; \$138,840.00 Fees

17. During the Application Period, White & Case advised the Debtors with respect to the preparation, review, and filing of critical first- and second-day motions. This work included drafting and revising motions concerning cash management [Docket No. 30], utilities [Docket No. 125], creditor matrix, business operations [Docket No. 34, 216], and ordinary course professionals, as well as workstreams related to operational procedures, tenant reimbursements, insurance issues (including insurance financing), tax issues, and resolving vendor and utility provider issues. This work also encompassed coordinating with the Independent Fiduciary, the Office of the United States Trustee (the "U.S. Trustee"), and other stakeholders.

### B05 Case Administration: 318.4 Hours; \$306,670.00 Fees

18. Due to the size and complexity of these Chapter 11 Cases, White & Case spent time on case administration to ensure its various attorneys were coordinated and did not duplicate services, the facts and legal issues were efficiently and clearly communicated to the Independent Fiduciary, and the efforts of White & Case and its co-advisors were coordinated and not duplicative. At the outset of the Chapter 11 Cases, White & Case spent substantive time on the initial steps of the Chapter 11 Cases, including: first day motions, the first day declaration, and other supporting documents [E.g., Docket Nos. 20, 44]; the master service lists; the creditor matrices [Docket No. 8–9]; the joint administration motion [Docket No. 7]; applications for

expedited consideration [Docket Nos. 16, 38]; the complex case management order [Docket No. 10]; and pro hac vice applications [Docket Nos. 11–13, 22–23]. Later in the case, White & Case prepared the chapter 11 petition for Laguna Reserve [Laguna Reserve, Docket No. 1], as well as the related motion to have certain orders in the jointly administered Chapter 11 Cases to also apply to Laguna Reserve [Docket No. 387], which was later granted [Docket No. 524].

19. Ongoing case administration included maintaining and updating internal case calendars, work in progress trackers, and document management; updating agendas and witness and exhibit lists for hearings; ordering hearing transcripts; and preparing and filing certificates of no objections, certificates of counsel, and similar pleadings. Throughout, there was continuous coordination both internally within White & Case and externally with the Independent Fiduciary and with our co-advisors regarding addressing outstanding issues, resolving deficiencies, and ensuring the Debtors' compliance.

### **B06** Case Strategy: 39.9 Hours; \$66,108.00 Fees

20. White & Case devoted substantial time and effort to developing and implementing a comprehensive strategy to advance the Chapter 11 Cases and maximize value for the Debtors' estates. White & Case professionals engaged in frequent coordination and strategy discussions (i) internally; (ii) with the Independent Fiduciary; and (iii) with the Debtors' other professionals.

### B07 Claims Administration & Objections: 117.8 Hours; \$138,125.00 Fees

21. During the Application Period, White & Case drafted, revised and filed a bar date motion and proposed order [Docket No. 132]; conducted extensive factual and legal research regarding certain proofs of claims filed against the Debtors' estates; responded to creditor inquiries and otherwise managed outreach to claimants; and drafted, revised, and filed substantive claim objections, stipulations, and supporting documents [Docket Nos. 372, 373, 599].

### B08 Financing Matters: NOLA: 246.0 Hours; \$317,536.00 Fees

During the Application Period, White & Case worked with IslandDundon LLC, the Debtors' financial advisor and investment banker, to negotiate, document, and close the DIP Financing for the NOLA Debtors, including drafting, revising, and filing (where applicable) term sheets [Docket No. 42], a DIP financing motion [Docket No. 61], documentation in support of same [Docket No. 156, 205], a proposed order to same [Docket No. 217], a reply in support of same [Docket No. 204], a stipulation regarding same [Docket No. 138], credit agreements, and related documents. In so doing, White & Case frequently conferred with the Independent Fiduciary, our co-advisors, the DIP lenders, and the U.S. Trustee to move the process forward, including responding to comments and objections, ensuring compliance with procedural and reporting requirements, and overseeing the successful closing of the DIP facility.

### B09 Financing Matters: Kelly Hamilton: 295.9 Hours; \$393,462.00 Fees

23. During the Application Period, White & Case worked with IslandDundon to negotiate, document, and close the DIP Financing for the Kelly Hamilton Debtors, including drafting, revising, and filing (where applicable) term sheets [Docket No. 42], a DIP financing motion [Docket No. 61], documentation in support of same [Docket No. 156, 205], a proposed order to same [Docket No. 217], a reply in support of same [Docket No. 204], credit agreements, and related documents. In so doing, White & Case frequently conferred with the Independent Fiduciary, the DIP lenders, and the U.S. Trustee to move the process forward, including responding to comments and objections, ensuring compliance with procedural and reporting requirements, and overseeing the successful closing of the DIP facility.

### B11 Exclusivity, Plan & Disclosure Statement: Kelly Hamilton: 806.3 Hours; \$1,059,021.00 Fees

24. During the Application Period, White & Case advised the Debtors throughout the

entire chapter 11 plan process with respect to the Kelly Hamilton Debtors. The White & Case team initially drafted, continuously revised, negotiated, and conducted research regarding the terms of the Kelly Hamilton Debtors' disclosure statement [Docket Nos. 247, 321, 339], the related KH Plan [Docket Nos. 246, 320, 338, 469, 500], and plan supplements [Docket No. 411, 502, 512], the motion seeking conditional approval of the disclosure statement [Docket No. 283, 284], materials regarding confirmation of the KH Plan [Docket No. 462, 471, 472], and a legal memorandum in support of same [Docket No. 470]. White & Case conferred frequently with the Independent Fiduciary, the Debtors' other advisors, the U.S. Trustee, and various stakeholders regarding timelines, plan proposals, solicitation procedures, the structure of the KH Plan and related disclosure statement, and various informal comments. White & Case also researched and prepared responses to the formal objections filed by parties, as well as stipulations resolving same where applicable. [Docket No. 504]. The White & Case team also provided advice with respect to managing the solicitation process, including preparing ballots and solicitation material. Finally, White & Case expended significant time preparing for the hearing on the confirmation of the KH Plan. All such efforts led to the successful confirmation of the KH Plan.

### B12 Executory Contracts & Unexpired Leases: 116.5 Hours; \$112,277.00 Fees

25. During the Application Period, White & Case advised the Debtors regarding its executory contracts and unexpired leases, including reviewing relevant agreements for key provisions, and drafting, revising, and filing motions to assume and/or reject the relevant agreements [Docket No. 128], as well as related declarations and exhibits in support, and notices regarding same [Docket No. 334, 362, 419, 436, 597]

### **B13 Hearings & Court Matters: 189.1 Hours; \$235,030.00 Fees**

26. White & Case prepared for and attended all of the hearings in these Chapter 11 Cases including, but not limited to: the first day hearing on May 27; the DIP financing hearing on

June 2; the second day hearing on June 17; the DIP financing and motion to dismiss hearing on June 26; the disclosure statement hearing on July 24; the bidding procedures hearing on August 14; the Silber motions hearing on August 21; the KH Plan confirmation and NOLA disclosure statement hearing on September 4; and the NOLA Plan confirmation hearing on October 22.

### B14 Litigation & Discovery: 337.8 Hours; \$365,428.00 Fees

- 27. During the Application Period, White & Case defended against a motion to dismiss the Chapter 11 Cases [Docket No. 87], including researching, drafting, revising and filing an objection to same and supporting declaration [Docket Nos. 175, 176], and handled related discovery and document production.
- 28. In parallel, White & Case was involved in other litigation and discovery workstreams, including drafting, revising, and filing a removal extension motion [Docket No. 385]; drafting a reply in support of DIP financing after formal objections were filed; opposing a motion to appoint an examiner; tracking pending actions involving the Debtor across various jurisdictions, including maintaining detailed litigation charts; and communicating with various regulatory authorities, such as the SEC.

### B16 Professional Retention & Fees – W&C: 141.5 Hours; \$176,690.00 Fees

29. During the Application Period, White & Case drafted its Retention Application and supporting documents, including, but not limited to: reviewing and revising the potential parties in interest list; reviewing reports generated by its conflicts department to determine whether it had connections to be disclosed in its Retention Application; revising and filing the Retention Application [Docket No. 173]; responding to U.S. Trustee comments regarding same; revising the proposed order to same; and drafting, revising, and filing supplemental declarations of Elizabeth LaPuma and Gregory F. Pesce regarding same [Docket Nos. 208, 209, 291, 437]. White & Case also worked on setting up and funding the professional fee escrow account to be used to fund the

fees and expenses of the Debtors' professionals and the Independent Fiduciary.

30. In accordance with the Admin Fee Order, White & Case also prepared and filed its monthly fee statements for May, June, July, August, September, and October;<sup>2</sup> certificates of no objection related to same; and, for the approved monthly fee statement, escrow instruction letters to disburse amounts from the professional fee escrow.

### B17 Professional Retention & Fees – Other: 259.0 Hours; \$304,938.00 Fees

31. During the Application Period, White & Case assisted the Debtors in: drafting and/or revising the retention applications of its co-advisors, including Kurtzman Carson Consultants, LLC dba Verita Global [Docket Nos. 37, 140], IslandDundon LLC [Docket No. 254], Hilco Real Estate, LLC [Docket No. 327, 329], Larry G. Schedler & Associates, Inc. [Docket No. 328], and Ken Rosen Advisors PC [Docket No. 174]; conferring with the U.S. Trustee regarding comments to such retention applications; revising the proposed orders granting such retention applications; and assisting in preparing supplemental declarations for same [Docket Nos. 215, 220, 223, 416, 417, 418, 439, 440, 441, 442, 443, 513]. White & Case also drafted an amendment to the engagement letter for the Independent Fiduciary. White & Case also drafted and filed an ordinary course professional motion [Docket No. 270] and an administrative fee procedures motion [Docket No. 272].

### B18 Reports, Schedules & U.S. Trustee Issues: 139.1 Hours; \$155,453.00 Fees

32. During the Application Period, White & Case assisted the Debtors in preparing, reviewing, revising and filing the Debtors' schedules and statements of financial affairs, monthly operating reports, and related motions and orders. White & Case team where appropriate coordinated with the U.S. Trustee and interested parties to incorporate their comments and held

The monthly fee statements for September and October were finalized and filed after the end of the Application Period.

numerous calls and conferences with the Debtors and their co-advisors to address open issues and ensure accuracy of the reporting. White & Case also supported the Debtors in attending the initial debtor interview under section 341.

### B19 Development of Claims and Causes of Action: 879.7 Hours; \$1,008,822.00 Fees

- 33. During the Application Period, White & Case devoted substantial time and effort to analyzing potential claims and causes of action of the Debtors' estates against third parties, including, but not limited to, Mr. Silber. In connection with these efforts, White & Case incurred significant time conducting factual research regarding such potential claims and causes of action, including reviewing documents, and conducting legal research regarding such potential claims and causes of action. In light of such investigations, White & Case drafted potential complaints asserting various causes of action against third parties.
- 34. On July 18, 2025, White & Case filed a complaint initiating an adversary proceeding against Spano Investor LLC and Acquiom Agency Services, LLC (the "**Defendants**") to avoid a constructively fraudulent guaranty incurred by one of the Debtors and to avoid a related unperfected lien on property of that same Debtor. [Docket No. 297; Case No. 25-01295-MBK, Docket No. 1]. Thereafter, White & Case negotiated and drafted a stipulation between the Debtors and the Defendants to hold the adversary proceeding in abeyance pending certain conditions and setting forth certain treatment of the Defendants' claim.
- 35. White & Case also represented the Debtors in opposing various contested matters initiated by Mr. Silber in the main Chapter 11 Cases, including, but not limited to, preparing and filing an objection to Mr. Silber's motion to appoint an equity committee [Docket No. 374], an objection to Mr. Silber's motion seeking discovery from the Debtors [Docket No. 375], and supporting declaration [Docket No. 376]. White & Case also filed a motion seeking leave to

depose Mr. Silber at the prison incarcerating him, which was later approved by the Court [Docket No. 378]; prepared for and took the deposition of Mr. Silber; and prepared and filed a motion to transfer Mr. Silber's chapter 7 case to the District of New Jersey [Docket No. 579]. White & Case also worked on producing documents to Mr. Silber (who was incarcerated at the time of production) and the SEC.

### B20 Asset Sales: NOLA: 196.6 Hours; \$288,914.26 Fees

36. During the Application Period, White & Case advised the Debtors with respect to all aspects of the Debtors' sale of the NOLA properties and related assets, culminating in the sale of the NOLA Properties to Lynd Acquisitions Group. This included: review and negotiation of the asset purchase agreements and ancillary documents; drafting and revising bidding procedures; drafting and filing the related sale motion, supporting declaration and proposed orders [Docket No. 350]; drafting related notices of same; reviewing bids and advising the Debtors regarding same; drafting the notice of the completion of the auction and the successful bidder; reviewing closing documents; and coordinating with multiple parties regarding sale strategy and auction processes.

### B21 Exclusivity, Plan & Disclosure Statement: NOLA: 357.1 Hours; \$445,029.00 Fees

37. During the Application Period, White & Case prepared, revised, and filed the NOLA Debtors' disclosure statement [Docket No. 390, 503, 517]; a motion requesting approval of same [Docket No. 391]; related solicitation materials (including ballots and liquidation analysis) [Docket No. 508]; the NOLA Plan and related materials, including Plan supplements [Docket No. 389, 501, 587, 603, 622, 647]; a motion to extend exclusivity [Docket No. 555]; and a memorandum and declarations in support of confirmation [Docket Nos. 617, 618, 619, 632]. In connection with same, White & Case incorporated feedback from the Independent Fiduciary, our

co-advisors, the U.S. Trustee, and other stakeholders. The White & Case team also advised regarding the management of the solicitation process, including preparing ballots and solicitation material. Finally, White & Case expended significant time preparing for the hearing on the confirmation of the NOLA Plan, including conferring with stakeholders regarding comments, concerns or objections to Plan confirmation. All such efforts led to the successful confirmation of the NOLA Plan.

### **DOCUMENTATION IN SUPPORT OF RELIEF REQUESTED**

- 38. By this Application, White & Case seeks final allowance of reasonable compensation for legal services rendered and reimbursement of actual, reasonable, and necessary expenses incurred on behalf of the Debtors for the Application Period, in the amount of \$6,091,471.22, consisting of \$6,023,906.00 in fees and \$67,565.22 in expenses. In support thereof, White & Case submits the following documentation:
  - (a) A summary of total fees and hours by timekeeper for the Application Period is provided in Section I of the cover sheets hereto.
  - (b) A summary of total fees and hours by project category for the Application Period is provided in Section II of the cover sheets hereto.
  - (c) A summary of total fees and hours by project category and by timekeeper for the Application Period is attached hereto as **Exhibit A**;
  - (d) A summary of expenses for the Application Period is provided in Section III of the cover sheets hereto;
  - (e) Detailed statements of hours and fees for the Application Period are attached to the monthly fee statements [Docket Nos. 369, 403, 557, 591, 676, 677], which are incorporated herein by reference;
  - (f) A detailed statement of expenses for the Application Period is attached hereto as **Exhibit B**;
  - (g) The customary and comparable compensation disclosures for White & Case are attached hereto as **Exhibit C**; and
  - (h) A summary of the Application for the Application Period, based on U.S. Trustee Guidelines Exhibit E, is attached hereto as **Exhibit D**.

### **COMPENSATION EARNED BY WHITE & CASE**

- 39. White & Case seeks final allowance of compensation incurred in connection with services rendered by White & Case to the Debtors during the Application Period in the amount of \$6,023,906.00.
- 40. Section 330(a)(1)(A) of the Bankruptcy Code authorizes "reasonable compensation for actual, necessary services" incurred by professionals and paraprofessionals employed in Chapter 11 Cases. Section 330(a)(3) instructs bankruptcy courts to "consider the nature, the extent, and the value of such services, taking into account all relevant factors, including—
  - (A) the time spent on such services;
  - (B) the rates charged for such services;
  - (C) whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of, a case under this title;
  - (D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed;
  - (E) with respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field; and
  - (F) whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under this title."
- 41. Applying the above factors, White & Case submits that its request for compensation is reasonable for the actual, necessary services that it provided.
- 42. White & Case is an international law firm with a widely recognized expertise in the area of restructuring, bankruptcy, and corporate reorganizations. Given the size, complexity, fast pace, and litigiousness of these Chapter 11 Cases, the professional services rendered by White & Case on behalf of the Debtors during the Application Period required a high level of legal services, including extensive time worked at night and on weekends.<sup>3</sup> During the Application Period, White

Approximately 9.6% of all hours billed within this Application were worked on a Saturday or Sunday.

& Case professionals and paraprofessionals billed their time—4,964.5 hours—for services rendered on behalf of the Debtors to twenty (20) distinct project categories described above. White & Case timekeepers documented their time in tenth of an hour increments and provided detailed descriptions of the tasks associated with each time entry. The fees charged by White & Case in these Chapter 11 Cases are billed in accordance with White & Case's standard billing rates and procedures in effect during the Application Period. Such fees are reasonable based on the customary compensation charged by comparably skilled practitioners in comparable non-bankruptcy cases in a competitive national legal market.

43. White & Case respectfully submits that the compensation and reimbursement requested in the Application are reasonable, actual and necessary as required by section 330 of the Bankruptcy Code given (a) the complexity of these Chapter 11 Cases, (b) the time expended, (c) the quality, nature and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services in the non-bankruptcy context.

### **EXPENSES INCURRED BY WHITE & CASE**

44. Section 330 of the Bankruptcy Code authorizes "reimbursement for actual, necessary expenses" incurred by professionals and paraprofessionals employed in Chapter 11 Cases. Accordingly, White & Case seeks allowance of expenses incurred in connection with services rendered by White & Case to the Debtors during the Application Period in the amount of \$67,565.22. The itemized expenses for White & Case professionals and paraprofessionals performing services for the Debtors during the Application Period are attached hereto. White & Case made every effort to minimize its expenses in these Chapter 11 Cases. The expenses incurred in the rendition of professional services were necessary, reasonable, and justified under the circumstances to serve the Debtors.

#### U.S. TRUSTEE GUIDELINES

45. With respect to Section C.5 of the U.S. Trustee Guidelines, White & Case provides answers to the following questions with respect to the Application Period:

Did you agree to any variations from, or alternatives to, your standard or customary billing rates, fees or terms for services pertaining to this engagement that were provided during the Application Period? If so, please explain.

#### No.

If the fees sought in this fee application as compared to the fees budgeted for the time period covered by this fee application are higher by 10% or more, did you discuss the reasons for the variation with the client?

Prior to these chapter 11 cases, the Debtors lacked funding to prepare an orderly chapter 11 filling and much of the work that would have typically occurred prior to the commencement of the chapter 11 cases occurred postpetition. Additionally, during these chapter 11 cases, White & Case advised the Debtors as the Debtors faced a variety of challenging operational, financial, and other challenges, including: (1) the Debtors required access to DIP financing to fund the administrative costs of the chapter 11 cases, including preparing all first day motions and negotiating interim and final DIP orders; (2) despite his criminal conviction and incarceration, the Debtors were required to respond to several pleadings filed by Mr. Silber, the Debtors' ultimate equity owner, including (a) a Rule 2004 discovery request [Docket No. 375], (b) a motion for appointment on an equity committee [Docket No. 374], and (c) proofs of claim [Docket No. 372]; (3) the Debtors were also required to take additional actions against Mr. Silber, including (a) seeking Rule 2004 discovery from Mr. Silber during his incarceration, (b) filing a motion to transfer the venue of Mr. Silber's personal bankruptcy case, and (c) preparing a draft complaint against Mr. Silber; (4) in connection with confirmation of the KH Plan, the Debtors were required to respond to objections filed by Chardell Bacon, the City of Pittsburgh, and the U.S. Trustee; and (5) in connection with confirmation of the NOLA Plan, the Debtors were required to respond to objections filed by The Sewerage and Water Board of New Orleans and OSL Investment VI, LLC. As a result of those challenges, White & Case exceeded its initial fee budget presented to the Independent Fiduciary. The Independent Fiduciary subsequently authorized and directed White & Case to provide advice and assistance notwithstanding the amount of the original budget presented to the Debtors at the outset of these chapter 11 cases.

Have any of the professionals included in this fee application varied their hourly rate based on the geographic location of the bankruptcy case?
