PLEASE READ THIS NOTICE CAREFULLY

Deadline to send new brokerage account information (if desired) is September 11, 2025

On June 30, 2025, the City of Detroit's Disbursing Agent attempted to transfer "New B Notes" to the brokerage account you identified on account of a Class 14 Claim you hold in the City of Detroit's Bankruptcy Case. Although numerous other claimants received their New B Notes, the City's attempted Distribution to your account was unsuccessful. Shortly after the Deadline, the City of Detroit's Distribution Agent will make an additional attempt to transfer New B Notes to your account using information you previously provided (or, if received by the Deadline indicated above, using updated information).
