ORDER SETTING STATUS CONFERENCE

On November 25, 2025, Diablo Grande Community Facilities District No. 1 ("Debtor") filed a chapter 9 voluntary petition. Doc. #1. On November 26, 2025, the undersigned was appointed as the bankruptcy judge in this case. Doc. #5. To facilitate the proceedings before this court, IT IS HEREBY ORDERED that:

1. Debtor, by and through counsel, appear at a status conference on January 7, 2026, at 9:30 a.m. in Department A, Courtroom 11, Fifth Floor, United States Courthouse, 2500 Tulare Street, Fresno, California. The subjects to be considered at the status conference shall include (a) progress of the case, (b) deadline for providing the notice of the commencement of the case required by 11 U.S.C. § 923, (c) deadline for filing objections to the petition, (d) deadline for filing the list of creditors required by Federal Rule of Bankruptcy Procedure 1007(e), and (e) such other matters as might aid or impair the progress and/or administration of the case.

2. Any creditor or party in interest may, in its discretion, be heard on that date and time and at that place.

1 3. Not later than December 31, 2025, Debtor shall, and any
2 creditor or party in interest may, file and serve a status
3 conference statement.

4 Debtor and other parties in interest can obtain information
