**SUPPLEMENTAL DECLARATION OF ADAM MEISLIK IN  
SUPPORT OF APPLICATION OF THE OFFICIAL COMMITTEE OF  
UNSECURED CREDITORS TO RETAIN AND EMPLOY FORCE TEN  
PARTNERS, LLC AS FINANCIAL ADVISOR EFFECTIVE AS OF MAY 23, 2025**

I, Adam Meislik, being duly sworn, hereby states as follows:

1. I am authorized to submit this supplemental declaration (the “**Declaration**”) in support of the *Application of the Official Committee of Unsecured Creditors to Retain Force Ten Partners, LLC as Financial Advisors Effective as of May 23, 2025* (the “**Application**”) in the above-captioned bankruptcy cases (the “**Chapter 11 Cases**”) of the debtors and debtors-in-possession (the “**Debtors**”).<sup>2</sup>

2. I am an Officer of Force Ten Advisors, LLC (“**Advisors**”), an advisory firm with its principal office located at 5271 California Ave., Suite 270, Irvine, California, 92617. I am also a Member of Force Ten Partners, LLC (“**Partners**”).

3. Except as otherwise noted, I have personal knowledge of the matters set forth herein and, if called as a witness, would testify competently and to the best of my knowledge and belief.<sup>3</sup>

4. Partners completed a strategic investment transaction effective January 2, 2026, and the financial advisory group which has served the Official Committee of Unsecured Creditors (the “**Committee**”) since May 23, 2025, and will continue to serve, is now operating out of an entity named Force Ten Advisors, LLC. Partners is an affiliate of Advisors. The new entity that will be providing services to the Committee will be Advisors, d/b/a Force 10 and Force 10 Partners.

5. The conflicts check performed by Partners prior to the change included all affiliates that would be involved in the structural change.

6. Certain professionals who provide services on behalf of Advisors are employees of an affiliate of Advisors, which provides payroll and employee benefits as an internal administrative matter. The Debtors’ will compensate only Advisors and Partners, and no portion of such compensation will be paid to, allocated to, or reimbursed to any other affiliate.

7. As of January 1, 2026, the customary hourly rates charged by Advisor’s professionals assigned to these cases are as follows:
