Dear Jim,

Subject to the terms of this Retention Bonus Agreement you shall receive a retention bonus in the total amount of \$170,000.00 (the "Total Retention Award Amount"). The Company or its successor(s) shall pay you \$85,000.00, less taxes and ordinary payroll deductions and withholdings on January 2, 2024, and \$85,000.00, less taxes and ordinary payroll deductions and withholdings on June 14, 2024, provided that you remain employed by the Company or its successor(s) on the payments dates.

In the event that the Company or its successor(s) terminate your employment without Cause, or you terminate your employment for Good Reason before any of the payment dates, you shall be paid the Total Retention Award Amount, less any portion of the Total Retention Award Amount previously paid to you, subject to the execution of a mutual release satisfactory to the Company or its successor(s).

This Retention Bonus Agreement supplements (and does not replace) the terms of your Employment Offer/Agreement dated March 31, 2023. Capitalized terms used herein shall have the same meaning as in your Employment Offer/Agreement.
