SUPPLEMENTAL DECLARATION OF MARIA ORFANIDOU IN SUPPORT OF ELETSON HOLDINGS INC.'S APPLICATION FOR ATTORNEYS' FEES AND COSTS

I, Maria Orfanidou hereby declare, pursuant to section 1746 of title 28 of the United States Code, as follows:

1. I am a founding member and managing partner at the law firm of D.K. Avgitidis & Associates ("Avgitidis"), a law firm based in Greece. I earned my law degree from the Law School of Democritus University of Thrace and hold a Master of Law degree (LL.M.) in Corporate Law from the Law School of Heidelberg (Karls–Ruprecht Universität Heidelberg–Germany). I have served on several legislative committees in Greece, including (i) the committee responsible for the reorganization of the Greek Energy Market and the establishment of the Greek Energy Exchange, codified in Law No. 4512/2018 (Arts. 73 et seq.); (ii) the committee that revised the Greek Bankruptcy Code under Law No. 4446/2016 and drafted Presidential Decree 133/2016 concerning insolvency administrators; and (iii) the committee focused on the streamlining of bankruptcy procedures for small businesses. I have contributed extensively to legal scholarship in the fields of

Prior to November 19, 2024, the Debtors in these cases were: Eletson Holdings Inc., Eletson Finance (US) LLC, and Agathonissos Finance LLC. On March 5, 2025, the Court entered a final decree and order closing the chapter 11 cases of Eletson Finance (US) LLC and Agathonissos Finance LLC. Commencing on March 5, 2025, all motions, notices, and other pleadings relating to any of the Debtors shall be filed in the chapter 11 case of Eletson Holdings Inc. restructuring and bankruptcy law. Most recently, I participated as a co-author in the commentary *The Law of Corporate Restructuring: Interpretation of Articles 31–64 & 74 of Law No. 4738/2020* (ed. Prof. D. Avgitidis, Nomiki Bibliothiki, 2024), the first comprehensive, article-by-article interpretation of Greece's corporate restructuring framework. I also have significant experience as a litigator in insolvency cases, including bankruptcy and restructuring matters.

- 2. I submit this supplemental declaration (this "Supplemental Declaration") in support of Eletson Holdings Inc.'s Application for Attorneys' Fees and Costs (the "Fee Application"), filed contemporaneously herewith, and as a supplement to Declaration of Maria Orfanidou In Support of Eletson Holdings Inc.'s Motion for Entry of an Order Awarding Attorney's Fees and Costs [Dkt. No. 1599] (the "Original Declaration").² The Original Declaration, which I adopt in full here and incorporate by reference, was submitted in support of the Motions for Entry of an Order Awarding Attorneys' Fees and Costs [Docket No .1597] (the "Attorneys' Fee Motion"), filed on April 16, 2025.
- 3. A hearing on the Attorneys' Fee Motion was heard on May 15, 2025. I understand that during that hearing, the Bankruptcy Court granted the Attorneys' Fee Motion, subject to Holdings filing an application for fees and costs. On July 2, 2025, the Court entered the *Order Awarding Attorneys' Fees and Costs* [Docket No. 1712] (the "Attorneys' Fees Order"), which approved the Attorneys' Fee Motion. As set forth in the Original Declaration and below, Holdings required Avgitidis' legal services in response to several of the actions of the "Violating Parties" as that term is defined in the Attorneys' Fee Order.

4. I am authorized to submit this Supplemental Declaration, and if called upon to testify, could and would testify competently to the facts and opinions set forth herein in accordance with the Greek Code of Conduct for the Legal Profession. Unless otherwise stated in this Declaration, I have personal knowledge of the facts and views set forth herein.

Fees and Costs Related to the Greek Proceedings

- 5. Avgitidis represents Eletson Holdings Inc. ("Holdings") in a series of legal proceedings currently pending before courts in Greece (collectively, the "Greek Proceedings"). An initial summary of the Greek Proceedings and the related Avgitidis legal services is set forth in the Original Declaration. In addition to the Greek Proceedings and Avgitidis legal services set forth in the Original Declaration, Avgitidis provided the following legal services to Holdings in relation to the Violating Parties' (as defined in the Attorneys' Fee Order) actions taken in opposition to recognition of and implementation of the Plan and Confirmation Order:
 - Appeared before the Piraeus Court on April 28 for the hearing of the Preliminary Injunction Petition and the Counter-Petition for Injunction, during which an adjournment was granted.
 - Drafted and filed two memorandums with the court on April 28—one opposing the petitioners' request for a temporary order, and the other supporting the counterpetitioner's request for a counter temporary order.
 - Appeared before the Piraeus Court on May 23 for the hearing of the Preliminary Injunction Petition and the Counter-Petition for Injunction.
 - Drafted and filed post-hearing memorandums with the court, opposing the Preliminary Injunction Petition and supporting the Counter-Petition for Injunction.
 - Communicated material updates and attended to communications with Holdings.
- 6. The fees and costs of Avgitidis, related to Holdings, were incurred due to the actions taken by the Violating Parties (as defined in the Attorneys' Fee Order) and specifically because of the Violating Parties' non-compliance with this Court's decisions and orders, including by interfering with the recognition and implementation of the Plan and Confirmation Order.
