IT IS HEREBY ORDERED;

1. Interim compensation and reimbursement of expenses for the Professionals are

hereby allowed as set forth in this Order, including **Exhibit A** attached hereto.

2. Unless otherwise ordered by the Court or agreed by the applicant, the entry of this

Order is without prejudice to the right of the Professionals at future hearing to request the

allowance and payment of compensation and/or expenses in amounts in excess of these allowed

pursuant to the first decretal paragraph of this Order for the periods covered by the Interim Fee

Applications for allowance and payment of compensation and expenses considered at the hearing.

3. The Trustee is authorized and directed to promptly disburse to each Professional

payment in the amount of the difference between (a) one hundred percent (100%) of the total fees

and expenses allowed herein for such Professional as set forth in Column (9) on Exhibit A attached

hereto and (b) the actual payments received by such Professional for the period covered herein,

subject to final allowance by the Court pursuant to the terms of the Interim Compensation

Procedures Order.

4. The Trustee is authorized and empowered to take such actions as may be necessary

and appropriate to implement the terms of this Order.

5. This Court shall retain jurisdiction with respect to all matters related to the

interpretation or implementation of this Order.

6. This Order shall be effective immediately upon entry.
