Claudia Z. Springer, in her capacity as Chapter 11 Trustee (the "<u>Trustee</u>") of the estates of Saga Formations, Inc. f/k/a Epic Creations, Inc. ("<u>Saga</u>"), Pajeau, Inc. f/k/a Neuron Fuel, Inc. ("<u>Pajeau</u>"), and Tangible Play, Inc. ("<u>Tangible Play</u>," together with Saga and Pajeau, collectively the "<u>Debtors</u>"), by and through her undersigned counsel, hereby submits this notice (the "<u>Notice</u>") identifying a certain claims that has been satisfied in full (the "<u>Fully Satisfied Claims</u>"). A list of the Fully Satisfied Claims is attached hereto as <u>Exhibit A</u>. In support of this Notice, the Trustee respectfully represents as follows:

BACKGROUND

1. On June 4-5, 2024 (the "<u>Petition Date</u>"), GLAS Trust Company LLC, in its capacity as administrative and collateral agent under the November 24, 2021 Credit and Guaranty

The Debtors in these chapter 11 cases, along with the last four digits of each Debtor's federal tax identification number, are: Saga Formations, Inc. f/k/a Epic Creations, Inc. (9113); Pajeau, Inc. f/k/a Neuron Fuel, Inc. (8758); and Tangible Play, Inc. (9331).

Agreement and certain other lenders under the Credit Agreement filed involuntary petitions under chapter 11 of the Bankruptcy Code in this Court against the Debtors (these "Chapter 11 Cases").

- 2. On September 16, 2024, this Court entered an Order for Relief in Involuntary Cases and Appointing Chapter 11 Trustee [D.I. 147].
- 3. On September 23, 2024 (the "Appointment Date"), the United States Trustee filed an Application for Entry of An Order Approving the Appointment of Claudia Z. Springer, Esq. as Chapter 11 Trustee [D.I. 151] and filed a Notice of Appointment appointing Claudia Z. Springer, Esq. as Trustee of the Debtors [D.I. 152]. Since that time, the Trustee has managed the Debtors' affairs pursuant to section 1106 of the Bankruptcy Code. No official committee has been appointed in these Chapter 11 Cases.
- 4. A more detailed description of the background of the Debtors and these Chapter 11 Cases is set forth in the *Declaration of Claudia Z. Springer in Support of First Day Motions* [D.I. 193].
- 5. On February 21, 2025, the Court entered the *Order (I) Establishing Bar Dates for Filing Proofs of Claim, Including Claims under 11 U.S.C. §§ 507(A)(3) through (A)(10) and 503(B)(9), (II) Approving the Form and Manner for Filing Proofs of Claim, (III) Approving Notice Thereof, and (IV) Granting Related Relief [D.I. 530] (the "Bar Date Order"). The Bar Date Order established, among other things, March 26, 2025, as the general claims bar date for the filing of proofs of claim asserting Claims against the Debtor arising before the Petition Date (the "General Bar Date").*
- 6. A chapter 11 plan has been filed in these Chapter 11 Cases, *see* D.I. 871, and a confirmation hearing is scheduled for September 24, 2025.

CLAIMS SATISFIED AFTER THE PETITION DATE

- 7. The Trustee has reviewed, or caused its professionals to review, the Debtors' books and records, the Schedules and Statements, the filed proofs of claim, and the filings in these Chapter 11 Cases, and has determined that the Fully Satisfied Claim listed on **Exhibit A** have been satisfied in full by way of (1) the *Order (I) Authorizing the Rejection of the Tangible Play Logistics Services Agreements and Abandonment Of Related Personal Property Effective as of April 21, 2025; and (II) Granting Related Relief* [D.I. 678] (the "Rejection Order") whereby the Trustee rejected the contracts associated with the Claims listed in **Exhibit A** and abandoned all personal property to those same parties to dispose of in a manner they saw fit, or (2) the *Order Approving Agreed Order Resolving Moduslink Claimant's Requests for Allowance and Payment of Administrative Expense Claims* [D.I. 786] (the "ModusLink Order").
- 8. Accordingly, the Trustee intends to designate on the claims register in these Chapter 11 Cases that the Fully Satisfied Claims have been previously satisfied as provided for herein and on **Exhibit A** attached hereto. The Trustee is serving this Notice on the parties holding the Fully Satisfied Claims providing such parties with an opportunity to object to the Trustee's position that such amounts have been paid in full.
- 9. ANY PARTY DISPUTING THE TRUSTEE'S POSITION THAT A PARTICULAR FULLY SATISFIED CLAIM HAS BEEN SATISFIED OR AS PROVIDED HEREIN AND ON EXHIBIT A ATTACHED HERETO MUST FILE A WRITTEN RESPONSE WITH THE CLERK OF THE UNITED STATES BANKRUPTCY COURT FOR THE DISTRICT OF DELAWARE, 824 N. MARKET STREET, 6th FLOOR, WILMINGTON, DELAWARE 19081 ON OR BEFORE AUGUST 20, 2025 AT 4:00 P.M. (ET) (THE "RESPONSE DEADLINE"), AND SERVE SUCH RESPONSE ON THE

UNDERSIGNED COUNSEL TO THE TRUSTEE.

- 10. In the event of a timely objection or response, the Trustee will make a reasonable effort to review the Fully Satisfied Claims with the objecting/responding claimant to determine whether any asserted amount was, in fact, not satisfied. In the event that the parties are unable to reach a resolution, the Trustee anticipates that a hearing will be held on the matter at a date and time to be determined by the Trustee, in its discretion, subject to the Court's availability.
- 11. Questions concerning this Notice should be directed to the undersigned counsel for the Trustee. Claimant should not contact the Clerk of the Court to discuss the merits of their Fully Satisfied Claims or this Notice.

RESERVATION OF RIGHTS

12. The Trustee reserves any and all rights to amend, supplement, or otherwise modify this Notice and to file additional notices of this nature and objections to claims with respect to any and all claims filed and amounts scheduled in these Chapter 11 Cases. The Trustee also reserves any and all rights, claims, and defenses with respect to any and all of the Fully Satisfied Claims, and nothing included in or omitted from this Notice is intended or should be construed as (i) an admission as to the validity of any claim, (ii) a waiver of the Trustee's right to dispute any claim on any grounds, (iii) a promise or requirement to pay any claim, (iv) a waiver of limitation of any of the Trustee's rights under the Bankruptcy Code or applicable law, or (v) a waiver of any party's rights to assert that any other party is in breach or default of any agreement.
