LITIGATION TRUSTEE'S NOTICE OF SATISFACTION OF CLAIMS

Finnbarr O'Connor (the "<u>Trustee</u>"), in his capacity as Successor Litigation Trustee for and on behalf of the Extended Stay Litigation Trust (the "<u>Trust</u>"), hereby files this notice (the "<u>Notice</u>") identifying claims filed or scheduled against the Debtors that have been satisfied, resolved, or are otherwise no longer valid (the "<u>Satisfied Claims</u>"). The Satisfied Claims are set forth on <u>Exhibit</u> <u>A</u> attached hereto. In support of this Notice, the Trustee respectfully represents as follows:

JURISDICTION AND VENUE

- 1. This Court has jurisdiction to consider this Notice under 28 U.S.C. §§ 157 and 1334. This is a core proceeding under 28 U.S.C. § 157(b). Venue of these cases and this Notice in this District is proper under 28 U.S.C. §§ 1408 and 1409.
- 2. The statutory predicates for the relief requested herein are Bankruptcy Code section 502 and Bankruptcy Rule 3007.

BACKGROUND

A. General

- 3. On June 15, 2009 or February 28, 2010 (the "<u>Petition Date</u>"), Extended Stay Inc. and its debtor affiliates (collectively, the "<u>Debtors</u>") filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code (the "<u>Chapter 11 Cases</u>"). The Debtors' chapter 11 cases were consolidated for procedural purposes only and were jointly administered.
- 4. Pursuant to orders entered on November 19, 2009 [Docket No. 595] and July 12, 2010 [Docket No. 1122] (together, the "Bar Date Orders") January 15, 2010 at 5:00 p.m. (prevailing Eastern Time) or August 17, 2010 at 5:00 p.m. (prevailing Eastern Time), as applicable, as the deadline (the "Bar Date") for the filing of proofs of claims based on prepetition claims.
- 5. Approximately 2,000 claims have been asserted in these Chapter 11 Cases, asserting liabilities in excess of \$95 billion.

B. The Litigation Trust

- 6. By order dated July 20, 2010 [Docket No. 1172] (the "Confirmation Order"), the Bankruptcy Court confirmed the Debtors' Fifth Amended Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code, dated June 8, 2010, as Amended (the "Plan"), which applies to all of the Debtors (collectively, the "Plan Debtors") other than Extended Stay Inc. ("ESI"). On October 8, 2010, the effective date of the Plan occurred.
- 7. The Trust was formed pursuant to the Plan and Confirmation Order. The Trust Assets (the "<u>Trust Assets</u>") are comprised of essentially all claims, potential claims, causes of actions, remedies, charges, suits or rights of recovery of the Debtors (i) referenced in the Report of Ralph R. Mabey, as Examiner, as amended [Docket Nos. 913, 1031, 1094, 1218] (the "Examiner's Report"), and (ii) under §§ 502(d), 542 through 551, and 553 of the Bankruptcy

Code (see Plan ¶ 1.89; ESI Settlement Agreement, § 4). Pursuant to the Plan and the Litigating Trust Agreement, the Trustee is responsible for, among other things, the disposition of the Trust Assets.

- 8. Pursuant to Article VII of the Plan, the Trustee is responsible for objecting to general unsecured claims and mezzanine facilities claims filed against the Plan Debtors. See Section 7.1(c) of the Plan. Additionally, pursuant to paragraph 1.89 of the Plan and section 4 of the ESI Settlement Agreement, the Trustee has the right from the Plan Debtors and ESI to object to claims under Bankruptcy Code section 502(d) in connection with the Trustee's obligation to dispose of Trust Assets (see Plan ¶ 1.89; ESI Settlement Agreement, § 4).
- 9. The Litigation Trustee commenced several causes of action. Pursuant to an Order entered on May 5, 2023 in Adversary Proceeding No. 11-2254, the Trustee has settled the last of the remaining litigations. As a result of the settlement, certain claims, including many of the Satisfied Claims, have been released and no longer remain valid claims against the estates.
- 10. The Trustee and its advisors have commenced a claims reconciliation process that includes identifying particular categories of claims that may be targeted for disallowance and expungement, reduction and allowance, or reclassification and allowance. Further, as part of this ongoing process, the Trustee and its professionals have concluded that each of the claims on **Exhibit A** have been satisfied, resolved, or are otherwise no longer valid. Accordingly, neither the Debtors nor their estates have any outstanding obligations on account of any of the Satisfied Claims identified on **Exhibit A** for the reason(s) identified therein.

RESPONSES TO THE NOTICE

11. The Trustee is serving this Notice on all parties holding Satisfied Claims and providing such parties with an opportunity to object to the Trustee's position that such claims have been satisfied, resolved, or are otherwise no longer valid as shown on **Exhibit A**. Any party

disputing the extent of the satisfaction of one or more Satisfied Claims must file a written response (a "Response") with the with the United States Bankruptcy Court for the Southern District of New York, electronically in accordance with the General Order M-399 (which can be found at http://www.nysb.uscourts.gov) by registered users of the Bankruptcy Court's case filing system and by all other parties in interest, in a text-searchable document format and with two hard copies delivered directly to the chambers of the Honorable James L. Garrity, and shall be served upon (i) Thompson Coburn LLP, attorneys for the Successor Litigation Trustee, 488 Madison Avenue, New York, NY 10011, Attn: Mark T. Power, Esq., and Joseph Orbach, Esq.; (ii) Weil, Gotshal & Manges LLP, 767 Fifth Avenue, New York, New York 10153, Attn: Jessica Liou, Esq., attorneys for the Debtors; (iii) the Office of the United States Trustee for the Southern District of New York, 33 Whitehall Street, 21st Floor, New York, New York 10004, Attn: Paul Schwartzberg, Esq.; (iv) Fried, Frank, Harris, Shriver & Jacobson LLP, One New York Plaza, New York, New York 10004, Attn: Jennifer Rodburg, Esq., attorneys for Newco; and (v) TREO Asset Management, foconnor@treoam.com, Attn: Finbarr O'Connor, so as to be filed and received by no later than July 28, 2023 at 4:00 p.m. (prevailing Eastern Time) (the "Response" Deadline").

- 12. Upon receipt of any response, the Trustee will confer with the claimant to determine whether any obligation remains outstanding and owing to such claimant. In the event that the parties are unable to reach a resolution, the Trustee will request that the Court schedule a hearing on the matter at an omnibus hearing.
- 13. If a claimant fails to file and serve a timely Response by the Response Deadline, (i) the claimant is deemed to have consented to the Notice and the Debtors' determinations with respect to its Satisfied Claim, as set forth therein, and (ii) the Debtors shall immediately, and

without further notice to any party (including the claimant), mark such Satisfied Claim as such on the claims register.

RESERVATION OF RIGHTS
