#### REORGANIZED DEBTORS' NOTICE TO CERTAIN CREDITORS THAT FILED PROOFS OF CLAIM ASSERTING ROYALTY AND WORKING INTERESTS

### PARTIES RECEIVING THIS NOTICE SHOULD LOCATE THEIR NAMES AND PROOF OF CLAIM IDENTIFIED ON EXHIBIT A **ATTACHED HERETO**

**PLEASE TAKE NOTICE** that the reorganized debtors (the "Reorganized Debtors"), by and through undersigned counsel, hereby file this notice (the "Notice") identifying certain proofs of claim filed against the debtors in the chapter 11 cases (the "Debtors") that assert claims based on alleged royalty and working interests in the Debtors' assets, which are defined in the Sixth Amended Joint Plan of Reorganization of Extraction Oil & Gas, Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code [Docket No. 1505] (the "Plan") as "Royalty and Working Interests." A list of the remaining proofs of claim that constitute Royalty and Working Interests is attached hereto as **Exhibit A**. In support of this Notice, the Reorganized Debtors

The Reorganized Debtors in these chapter 11 cases, along with the last four digits of each Reorganized Debtor's federal tax identification number, are: Extraction Oil & Gas, Inc. (3923); 7N, LLC (4912); 8 North, LLC (0904); Axis Exploration, LLC (8170); Extraction Finance Corp. (7117); Mountaintop Minerals, LLC (7256); Northwest Corridor Holdings, LLC (9353); Table Mountain Resources, LLC (5070); XOG Services, LLC (6915); and XTR Midstream, LLC (5624). The location of the Reorganized Debtors' principal place of business is 370 17th Street, Suite 5300, Denver, Colorado 80202. On October 25, 2021, the Court entered an order [Docket No. 2070] closing the chapter 11 cases of the Reorganized Debtors other than Case No. 20-11550 (CSS).



respectfully represent as follows:

- 1. On June 16, 2020, the Court entered an order [Docket No. 81] appointing Kurtzman Carson Consultants LLC ("KCC") as claims and noticing agent in the chapter 11 cases. Among other things, KCC is authorized to (a) receive, maintain, and record and otherwise administer the proofs of claim filed in the chapter 11 cases, and (b) maintain official claims registers for the Debtors (the "Claims Register").
- 2. On December 23, 2020, the Court entered the Findings of Fact, Conclusions of Law, and Order Confirming the Sixth Amended Joint Plan of Reorganization of Extraction Oil & Gas, Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code [Docket No. 1509] (the "Confirmation Order"), confirming the Plan.
- 3. On January 20, 2021, the Debtors substantially consummated the Plan and emerged from chapter 11 in accordance with the terms of the Plan and the Confirmation Order. On January 21, 2021, the Reorganized Debtors filed their *Notice of (A) Entry of Findings of Fact, Conclusions of Law, and Order Confirming the Sixth Joint Plan of Reorganization of Extraction Oil & Gas, Inc. and its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code, and (B) Occurrence of Effective Date [Docket No. 1652].*
- 4. Under the Plan, Royalty and Working Interests were not compromised or discharged, but instead were preserved and remain in full force and effect in accordance with the terms of the granting instruments or other governing documents applicable to such Royalty and Working Interests.
- 5. In the ordinary course of business, the Debtors maintained books and records (the "Books and Records") that reflect, among other things, the nature and amount of the liabilities owed to their creditors as of the Petition Date. The Reorganized Debtors have

reviewed the Books and Records and have determined that the remaining proofs of claim listed on **Exhibit A** assert Royalty and Working Interests as defined under the Plan, which are not affected by the Plan. Accordingly, the Reorganized Debtors intend to have KCC designate on the Claims Registers in these chapter 11 cases that the proofs of claim listed on **Exhibit A** are expunged because they assert Royalty and Working Interests as defined under the Plan.

- 6. Notwithstanding the expungement of the proofs of claim listed on **Exhibit A** from the Claims Register, all rights, defenses and obligations of the Reorganized Debtors and the holders of Royalty and Working Interests (including parties that filed the proofs of claim listed on Exhibit A) related to Royalty and Working Interests and the amount, if any, that may be due and owing by the Reorganized Debtors with respect to Royalty and Working Interests are preserved and remain in full force and effect. Any amounts due and owing with respect Royalty and Working Interests shall be resolved by the parties in the ordinary course of business between them or in the appropriate non-bankruptcy forum, if necessary. To the extent applicable, the Reorganized Debtors consent to relief from the injunctive provisions set forth in Article VIII.H of the Plan to permit the holders of Royalty and Working Interests (including parties that filed the proofs of claim listed on **Exhibit A**) to determine whether any amounts are due and owing by the Reorganized Debtors with respect to any Royalty and Working Interest. To the extent a court, arbiter, or other tribunal determines that the amounts are due for Royalty and Working Interests, such amounts are not property of the estate, and shall be paid by the Reorganized Debtors in the ordinary course of business.
- 7. Out of an abundance of caution, however, the Reorganized Debtors are serving this Notice on parties that filed the proofs of claim listed on **Exhibit A** to provide such parties

with an opportunity to object to the Reorganized Debtors' position that such proofs of claim assert only Royalty and Working Interests.

- 8. ANY PARTY DISPUTING THE REORGANIZED DEBTORS' POSITION THAT A PROOF OF CLAIM LISTED ON EXHIBIT A ASSERTS ONLY ROYALTY AND WORKING INTERESTS AS PROVIDED FOR HEREIN MUST FILE A WRITTEN RESPONSE WITH THE CLERK OF THE UNITED STATES BANKRUPTCY COURT FOR THE DISTRICT OF DELAWARE, 824 N. MARKET STREET, 3RD FLOOR, WILMINGTON, DELAWARE 19801 ON OR BEFORE JULY 25, 2024 AT 4:00 P.M. (ET), AND SERVE SUCH RESPONSE ON THE UNDERSIGNED CO-COUNSEL TO THE REORGANIZED DEBTORS.
- 9. If a response to this Notice is filed by a claimant, the Reorganized Debtors will review the respective proof of claim with the claimant to determine whether any asserted amounts are, in fact, not Royalty and Working Interests that were preserved under the Plan. In the event that the parties are unable to reach a resolution of any such objection, the Reorganized Debtors will ask the Court to resolve such dispute by this Notice or such other pleading as may be necessary to bring the issue before the Court.
- 10. Questions concerning this Notice should be directed to the undersigned cocounsel for the Reorganized Debtors. Claimants should not contact the Clerk of the Court to discuss the merits of their proof of claim or this Notice.

#### **Reservation Of Rights**

11. The Reorganized Debtors reserve any and all rights to amend, supplement, or otherwise modify this Notice and **Exhibit A** hereto, and to file additional notices of this nature and objections to claims with respect to any and all claims filed and amounts scheduled in these

chapter 11 cases. The Reorganized Debtors also reserve any and all rights, claims, and defenses with respect to any and all of the proofs of claim listed on **Exhibit A**, and nothing included in or omitted from this Notice is intended or should be construed as (i) an admission as to the validity of any claim, (ii) a waiver of the Reorganized Debtors' rights to dispute any claim on any grounds, (iii) a promise or requirement to pay any claim, (iv) an implication or admission that any claim is of a type referenced or defined herein or therein, (v) a waiver or limitation of any of the Reorganized Debtors' rights under the Bankruptcy Code or applicable law, or (vi) a waiver of any party's rights to assert that any other party is in breach or default of any agreement. The Reorganized Debtors reserve the right to remove any proof of claim listed on **Exhibit A** and assert that such proof of claim does not assert a Royalty and Working Interest.
