I, **Jorge A. Rouge**, hereby declare as follows:


1. I am the creditor and claimant in this matter, with Claim No. 3745 in the amount of \$5,250.
2. On August 19, 2025, I received an email from **Darlene S. Calderon of Verita Global**. The email asserted that I had been served with the **Bar Date Notice on August 21, 2024 at 6:14 p.m. PT**, via email to my account *grougekat@hotmail.com*. A screenshot from their third-party email platform was provided to me as “proof of service.” A copy of that correspondence and screenshot is attached hereto as **Exhibit C**.
3. I declare under penalty of perjury that I **never received this email** in my inbox, junk folder, or any other folder of my Hotmail account.
4. I routinely check my email daily, including my junk and spam folders, and I did not receive the August 21, 2024 Bar Date Notice or any other notice of the September 11, 2024 bar date from Verita Global, the Debtors, or the Court.
5. I was not aware of the September 11, 2024 bar date until a colleague informed me of the bankruptcy filing after the deadline had already passed.
6. Had I received actual notice of the bar date, I would have filed my claim before the deadline. My Proof of Claim was filed on September 16, 2024, only days after the bar date, once I learned of the case.
7. For these reasons, I respectfully maintain that I was denied proper notice of the bar date, and that my claim should not be disallowed solely as “late-filed.”
