**CERTIFICATION OF COUNSEL REGARDING REVISED PROPOSED ORDER

No other formal or informal responses or objections to the Motion were received.

To resolve the U.S. Trustee’s informal comments, the Debtor made certain revisions to the Proposed Order (the “**Revised Proposed Order**”), a copy of which is attached hereto as Exhibit A. For the convenience of the Court and all other interested parties, a blackline comparing the Revised Proposed Order against the Proposed Order is attached hereto as Exhibit B.
