PLEASE TAKE FURTHER NOTICE that, responses, if any, to the Motions must be made in writing no later than **May 23, 2025, at 4:00 P.M. (the “Response Deadline”)**.

Unless otherwise directed by the Court, you must file your response electronically at <https://ecf.txsb.uscourts.gov/>. If you do not have electronic filing privileges, you must file a written objection that is actually received by the clerk no later than the Response Deadline. Otherwise, the Court may treat the pleading as unopposed and grant the relief requested.

PLEASE TAKE FURTHER NOTICE that, parties may participate in the hearing either in person or by an audio and video connection. Audio communication will be by use of the Court’s dial-in facility. You may access the facility at 832-917-1510. Once connected, you will be asked to enter the conference room number. Judge Lopez’s conference room number is 590153. Video communication will be by use of the GoToMeeting platform. Connect via the free GoToMeeting application or click the link on Judge Lopez’s home page. The meeting code is “Judge Lopez”. Click the settings icon in the upper right corner and enter your name under the personal information setting. Hearing appearances must be made electronically in advance of both electronic and in-person hearings. To make your appearance, click the “Electronic Appearance” link on Judge Lopez’s home page. Select the case name, complete the required fields and click “Submit” to complete your appearance.
