### **CONSENT MOTION TO CORRECT ORDER**

Appellant Hunter Mountain Investment Trust ("HMIT") files this Consent Motion to Correct Order ("Consent Motion") and would respectfully show as follows:

1. The Court's July 2, 2025, Order [Doc. 40] ("Order") mistakenly states that the claims of Appellee Highland Capital Management, L.P., the reorganized debtor ("Debtor" or "Highland") were dismissed with prejudice, rather than the claims of Appellant HMIT. Only HMIT has affirmative claims that are the subject of this appeal,

not Highland nor the other appellees the Highland Claimant Trust ("Claimant Trust") or the Highland Litigation Sub-Trust ("Litigation Sub-Trust") (collectively "Appellees").

- 2. Accordingly, HMIT requests the Court strike the Order and instead enter a corrected order, substantially in the form attached hereto as **Exhibit A** ("Corrected Dismissal Order"), dismissing HMIT's claims against Appellees Highland, the Claimant Trust, and the Litigation Sub-Trust, in this appeal with prejudice.
- 3. HMIT represents that it has provided counsel Appellees with a copy of this Consent Motion and the proposed Corrected Dismissal Order, and that Appellees consent to the entry of the Corrected Dismissal Order.

WHEREFORE, HMIT respectfully requests the Court strike its July 2, 2025, Order [Doc. 40] and instead enter the Corrected Dismissal Order, substantially in the form attached hereto as <a href="Exhibit A">Exhibit A</a>, dismissing all claims asserted, or that could have been asserted, by Appellant Hunter Mountain Investment Trust, against Appellees Highland Capital Management, L.P., The Highland Claimant Trust, and James P. Seery, Jr. with prejudice.
