SierraConstellation Partners, LLC (“SCP”), as financial advisor for Higher Ground Education, Inc. (“HGE”) and its affiliated debtors and debtors in possession (collectively, the “Debtors”) in the above-captioned bankruptcy cases (the “**Chapter 11 Cases**”), hereby files its *First and Final Application of SierraConstellation Partners, LLC for Allowance and Payment Compensation and Reimbursement of Expenses Incurred as Financial Advisor to the Debtors for the Period from June 17, 2025 through December 16, 2025* (the “**Final Fee Application**”) for final allowance of fees in the amount of **\$363,702.50** and actual and necessary expenses in the amount of **\$1,618.61** for a total allowance of **\$365,321.11** for the period of June 17, 2025, through and including December 16, 2025 (the “**Final Fee Period**”). In support of this Final Fee Application, SCP respectfully represents as follows:

**I.**  
**JURISDICTION**

1. The United States Bankruptcy Court for the Northern District of Texas (the “**Court**”) has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b). The Debtors confirm their consent, pursuant to Rule 7008 of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”), to the entry of a final order by the Court. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

2. The bases for the relief requested herein are sections 328, 330, and 331 of title 11 of the United States Code (the “**Bankruptcy Code**”), Bankruptcy Rule 2016, Rule 2016-1 of the Local Rules of the United States Bankruptcy Court for the Northern District of Texas (the “**Local Rules**”), the Procedures for Complex Cases in the Northern District of Texas (the “**Complex Case Procedures**”), and the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals* [Docket No. 319 (the “**Interim Compensation Order**”) entered by the Court on August 11, 2025.

## **II.** **BACKGROUND**

### **A. The Chapter 11 Cases**

3. On June 17, 2025 and June 18, 2025 (collectively, the “**Petition Date**”), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors remain in possession of their property and are managing their businesses as debtors-in-possession pursuant to Sections 1107(a) and 1108 of the Bankruptcy Code. The court has not appointed a trustee and the official committee of unsecured creditors was appointed on July 9, 2025 [Docket No. 158] (the “**Committee**”).

4. A detailed description of the Debtors and their businesses, and the facts and circumstances supporting this Application and the Debtors’ Chapter 11 Cases, are set forth in the *Declaration of Jonathan McCarthy in Support of First Day Motions* [Docket No. 15] (the “**First Day Declaration**”) and is incorporated herein by reference.

### **B. Retention of SCP**

5. On July 14, 2025, the Debtors filed the *Debtors’ Application for Entry of an Order Authorizing the Employment of SierraConstellation Partners, LLC as Financial Advisor to the Debtors Effective as of the Petition Date* [Docket No. 173] (the “**SCP Application**”). On August 12, 2025, the Court entered an order approving the SCP Application [Docket No. 325] (the “**SCP Retention Order**”).<sup>2</sup> Under the SCP Retention Order, SCP agreed to provide the Debtors with the following advisory services (together with the services set forth in the Engagement Letter, collectively, the “**Services**”) related to the Chapter 11 Cases, including, but limited to:

- a. Provide assistance in the management of schedules and reporting for filing in a court-supervised proceeding;

- b. Provide management support in evaluating and responding to parties during negotiation including landlords, vendors, potential buyers, and other key constituents;
- c. Interact with the unsecured creditor committee (if one is formed in the Bankruptcy Case) and assist in the preparation of management reports;
- d. Provide analysis and services related to lease assumptions, rejections, modification or terminations;
- e. Assist in drafting and confirming a plan of reorganization, if necessary;
- f. Assist in the preparation of a plan of reorganization;
- g. Manage legal preparations for the Chapter 11 plan, including drafting required pleadings and disclosure statements, ensuring compliance with the Bankruptcy Code and Federal Rules of Bankruptcy Procedure, and coordinating with the debtor, creditors, and other stakeholders;
- h. Provide advice on restructuring alternatives, including but not limited to, any asset sales or a plan for reorganization; and
- i. Render such other restructuring, general business consulting or other assistance as may be requested.

6. Pursuant to the SCP Retention Order, SCP was to be compensated by the Debtors for the Services rendered in these Chapter 11 Cases based upon SCP's agreed-upon hourly rates for such Services.

### **C. Interim Compensation and Monthly Fee Statements**

7. On July 14, 2025, the Debtors filed *Debtors' Motion for Entry of an Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals* [Docket No. 174] (the "**Interim Compensation Motion**"). On August 11, 2025, the Court granted the Interim Compensation Motion and entered the Interim Compensation Order. [Docket No. 319].

8. Pursuant to the Interim Compensation Order, professionals retained by the Debtors and the Committee pursuant to section 327 of the Bankruptcy Code (collectively, the "**Estate Professionals**") were permitted to serve by email a statement (each a "**Monthly Fee Statement**")

upon certain specified Notice Parties to seek interim allowance of compensation for services rendered and expenses incurred during the prior month. Following the service of each Monthly Fee Statement upon the Notice Parties, the Notice Parties were provided ten (10) days after the date of service of the Monthly Fee Statement(s) (the “**Objection Period**”) to raise written objections, if any. At the expiration of the Objection Period, if no objections were raised, the Debtors were directed to promptly pay the applicable Professional 80% of the fees and 100% of the expenses requested in each Monthly Fee Statement (an “**Interim Compensation Payment**”), except such fees or expenses that may have been subject to an objection by the Notice Parties.

9. In accordance with the Interim Compensation Order, SCP served Monthly Fee Statements upon the Notice Parties via email for the months of (a) June 17, 2025 through July 31, 2025, (b) August 2025, (c) September 2025, (d) October 2025, and (e) November 2025 (collectively, the “**SCP Fee Statements**”). Through its submission of the SCP Fee Statements, SCP has requested a total of \$363,702.50 in fees and \$1,618.61 in expenses during the Final Fee Period. To date, SCP has been paid a total of \$283,814.61, comprised of \$282,196.00 in fees and \$1,618.61 in expenses.

10. A chart setting forth the fees and expenses incurred by SCP to date, as reflected in the Final Fee Application and the SCP Fee Statements is below.

### **III. REQUEST FOR RELIEF**

11. By this Final Fee Application, SCP respectfully requests entry of an order, substantially in the form attached hereto as **Exhibit A** (the “**Proposed Order**”), (a) approving final compensation for services rendered during the Final Fee Period, in the amount of **\$363,702.50**, as well as allowance of **\$1,618.61** as reimbursement for actual and necessary expenses incurred by SCP during the Final Fee Period; (b) directing payment of the total remaining unpaid amount of **\$81,506.50**; and (c) granting related relief.

### **IV. FEES EARNED DURING THE FINAL FEE PERIOD**

#### **A. Customary Billing Disclosures**

12. SCP maintains computerized records of the time spent by all timekeepers in connection with its representation of the Debtors. During the Final Fee Period, Three (3) professionals expended a total of 614.50 hours during the Final Fee Period for which compensation is requested. All services for which compensation is requested by SCP were performed for or on behalf of the Debtors. To the extent any compensation set forth above remains unpaid, SCP further requests payment of all unpaid amounts, including amounts previously held back pursuant to the Interim Compensation Order.

13. Except as set forth above, during the Final Fee Period, SCP has received no payment and no promises of payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with the matters covered by this Final Fee Application. There is no agreement or understanding between SCP and any other person, other than members of the firm, for the sharing of compensation to be received for services rendered in these Chapter 11 Cases.

14. The fees charged by SCP in this case are billed in accordance with SCP's normal hourly rates and procedures in effect during the Final Fee Period, and in accordance with the Retention Order. SCP did not agree to any variations from, or alternatives to, its standard or customary billing arrangements in connection with the services rendered during this Final Fee Period. SCP's fees are reasonable based on the customary compensation charged by comparably skilled practitioners in comparable non-bankruptcy cases in a competitive national financial advisory market.

15. Pursuant to, and in compliance with the Local Rules and the UST Guidelines set forth above, attached hereto are:

- a. a schedule setting forth the professionals who performed services in these Chapter 11 Cases during the Final Fee Period, the capacity in which each such individual is employed by SCP, the hourly billing rate charged by SCP for the services performed by such individual, and the aggregate number of hours expended in this case during the Final Period and fees billed therefore;
- b. a summary of services by billing category for services rendered by SCP during the Final Fee Period; and,
- c. a schedule setting forth the actual and necessary disbursements that SCP incurred during the Final Fee Period in connection with performance of professional services for the Debtors and for which SCP seeks reimbursement.

**B. Supporting Documentation**

16. For the convenience of the Court and parties in interest and in accordance with the UST Guidelines and the Complex Case Procedures, the following exhibits are attached to this Final Fee Application:

17. Attached hereto as **Exhibit B** is the Declaration of Carl Moore (the “**Moore Declaration**”);

18. Attached hereto as **Exhibit C** is a schedule setting forth all SCP professionals and paraprofessionals who performed services in these Chapter 11 Cases during the Final Fee Period, the hourly billing rates of such individuals, and the aggregate number of hours expended and fees billed by such individuals;

19. Attached hereto as **Exhibit D** is a summary of SCP’s time billed during the Final Fee Period, broken down by project categories, as hereinafter described;

20. Attached hereto as **Exhibit E** is a schedule specifying the categories of expenses for which SCP is seeking reimbursement and the total amount for each expense category for the Final Fee Period; and

21. Attached hereto as **Exhibit F** are SCP’s invoices for the Final Fee Period (the “**SCP Invoices**”). The SCP Invoices contain daily time logs describing the time spent by each professional during the Final Fee Period.

**V.  
ACTUAL AND NECESSARY EXPENSES**

22. SCP requests the final allowance of actual and necessary expenses incurred during the Final Fee Period in the aggregate amount of **\$1,618.61**. The attached **Exhibit E** summarizes SCP’s actual and necessary expenses for the Final Fee Period.

23. It is SCP's policy to charge its clients for all disbursements and expenses incurred in rendering services. Accordingly, SCP seeks reimbursement for necessary expenses incurred in connection with its representation of the Debtors, which shall include, but not be limited to, travel, photocopying, delivery service, postage, research, vendor charges, and other out-of-pocket expenses incurred in providing professional services.

**VI.**  
**SUMMARY OF SERVICES BY PROJECT CATEGORY**

24. The following is a summary of the significant professional services rendered by SCP during the Final Fee Period. This summary is organized in accordance with the internal system of task codes set up by SCP at the outset of these Chapter 11 Cases.<sup>4</sup> Given the interconnectedness of the issues in these Chapter 11 Cases, certain of these categories may overlap with one another. If a task code does not appear below, then SCP did not bill time for that work code during the Final Fee Period.

**A. Business Operations**  
**(315.70 Hours / \$185,165.00 Fees)**

25. During the Final Fee Period, SCP's services performed in connection with this category relate to working with the Debtors to maintain business operations and assisting the Debtors' management team with various issues arising in the conduct of the Debtors' business.

**B. Case Administration**  
**(165.50 Hours / \$97,422.50 Fees)**

26. During the Final Fee Period, SCP's services performed in connection with this category relate to all time and tasks related to the preparation/review/revision of the company's schedules, SOFAs, and monthly operating reports, preparation of any other

documents/reports/amendments related to the chapter 11 petition, etc. for court filing (other than Court pleadings) and related to docketing, review of the docket and general review of filed pleadings (i.e., not for use in connection with time and tasks related to active involvement with a particular motion/court hearing), service list issues, dealing with the claims agent, addressing the claims process and procedures, proofs of claim procedures, general requests for copies of documents.

**C. Court Filings  
(25.40 Hours / \$17,525.00 Fees)**

27. During the Final Fee Period, SCP's services performed in connection with this category relate to preparing, drafting, reviewing and revising pleadings, schedules or exhibits to pleadings, the disclosure statement, the plan, and adversary proceeding commenced during the Chapter 11 Cases and responding to requests from counsel for information to be included in pleadings, the disclosure statement, the plan or other document filed with the court.

**D. Court Hearings  
(43.40 Hours / \$26,855.00 Fees)**

28. During the Final Fee Period, SCP's services performed in connection with this category relate to time and tasks involving attendance at court hearings, either virtually or in person.

**E. Creditor Communications  
(38.90 Hours / \$23,907.50 Fees)**

29. During the Final Fee Period, SCP's services performed in connection with this category relate to all communications: oral and written with unsecured and secured creditors, vendors, trade creditors, noteholders, banks and professionals retained by the official committees or an ad hoc committee.

**F. Invoices**  
**(17.40 Hours / \$10,665.00 Fees)**

30. During the Final Fee Period, SCP's services performed in connection with this category relate to preparation and submission of the SCP Fee Statements to the Notice Parties.

**G. Litigation/Discovery**  
**(0.20 Hours / \$155.00 Fees)**

31. During the Final Fee Period, SCP's services performed in connection with this category relate to litigation involving the company that is not an adversary proceeding filed in connection with the Chapter 11 Cases.

**H. Litigation (Bankruptcy)**  
**(0.20 Hours / \$155.00 Fees)**

32. During the Final Fee Period, SCP's services performed in connection with this category relate to litigation involving the company that is filed in connection with the Chapter 11 Cases.

**I. Non-Working Travel**  
**(7.80 Hours / \$1,852.50 Fees)**

33. This matter category includes travel time by SCP professionals, which is billed at fifty percent (50%) of the standard hourly rates.

**VII.**  
**REQUEST FOR ALLOWANCE OF FEES AND EXPENSES**

34. Section 330 of the Bankruptcy Code authorizes the Court to award professional persons employed pursuant to section 327 for reasonable compensation for actual and necessary services rendered and reimbursement for actual and necessary expenses incurred. *See* 11 U.S.C. §§ 327 and 330. As more fully stated below, SCP submits that the elements governing awards of compensation pursuant to sections 330 and 331 of the Bankruptcy Code justify the allowance of the fees and expenses incurred in its representation of the Debtors during the Final Fee Period

35. In 1974, the Fifth Circuit established a set of guidelines for use by lower courts when ruling on attorneys' fee requests. *See Johnson v. Ga. Highway Express, Inc.*, 488 F.2d 714, 717–19 (5th Cir. 1974). The *Johnson* court found the following factors necessary to consider:

- a. the time and labor required;
- b. the novelty and difficulty of the questions presented;
- c. the skill requisite to perform the legal services properly;
- d. the preclusion of other employment due to the acceptance of the case;
- e. the customary fee;
- f. whether the fee is fixed or contingent;
- g. time limitations imposed by the client with the circumstances of the case;
- h. the amount involved and the results obtained;
- i. the experience, reputation and ability of the attorney;
- j. the undesirability of the case;
- k. the nature and length of the professional relationship with the client; and
- l. awards in similar cases.

*Id.* In the case of *In re First Colonial Corp. of America*, 544 F.2d 1291, 1298–99 (5th Cir. 1977), cert. denied, 431 U.S. 904 (1977), the Fifth Circuit applied the *Johnson* factors to the analysis of fee awards in bankruptcy cases.

36. SCP respectfully submits that the services for which it seeks compensation in this Final Fee Application were, at the time rendered, necessary for and beneficial to the Debtors and were rendered to assist the Debtors in discharging its statutory duties during the pendency of the Chapter 11 Cases. SCP further believes that its services to the Debtors during the Final Fee Period were performed efficiently and in an expert manner and ultimately benefitted the Debtors. SCP submits that the compensation requested herein is reasonable in light of the nature, extent, and

value of SCP's services to the Debtors. Accordingly, the Final Fee Application should be approved.

**VIII.**  
**SECTION 504(B) COMPLIANCE**

37. No agreement or understanding exists between SCP and any third person for the sharing of compensation, except as allowed by section 504(b) of the Bankruptcy Code and Bankruptcy Rule 2016 with respect to the sharing of compensation between and amongst shareholders at SCP.

38. All services for which compensation is requested hereunder were rendered at the request of and solely on behalf of the Debtors and Debtors' counsel and not on behalf of any other entity.

**IX.**  
**RESERVATION OF RIGHTS**

39. To the extent time or disbursement charges for services rendered or disbursements incurred relate to the Final Fee Period but were not processed prior to the preparation of this Final Fee Application, or SCP has for any other reason not sought compensation or reimbursement of expenses herein with respect to any services rendered or expenses incurred during the Final Fee Period, SCP reserves the right to request additional compensation for such services and reimbursement of such expenses in a future application.

**X.**  
**NOTICE**

40. SCP will provide notice of this Final Fee Application to (a) the Office of the United States Trustee for the Northern District of Texas; (b) the United States Attorney's Officer for the Northern District of Texas; (c) the state attorney generals for all states in which the Debtors conduct or have recently conducted business; (d) the Internal Revenue Service, (e) the Liquidating



Trustee; (f) Cozen O'Connor, as counsel to the Senior DIP Lender and Plan Sponsor; (g) Kane Russell Coleman Logan PC, as counsel to the Junior DIP Lender; and (h) all parties in interest who have formally appeared and requested notice pursuant to Bankruptcy Rule 2002. SCP respectfully submit that no further notice of this Final Fee Application is required.

41.
