- 2 Citizens Bank Account No. 2363 was opened in accordance with the Order (I) Approving the Settlement Agreement and Release Between the Debtor and the Certain Settling Insurers; (II) Approving the Sale of Certain Insurance Policies; (III) Issuing an Injunction Pursuant to the Sale of Certain Insurance Policies; and (IV) Granting Related Relief [Docket No. 442] requiring that the Debtor hold all funds paid to it under such order in a segregated bank account. Citizens Bank required an initial deposit of \$100 to open this account.
