ORDER DENYING MOTION TO QUASH DEPOSITION NOTICE

This matter came before the Court upon the *Motion to Quash Deposition Notice* [Dkt. 904] (the “Motion”) filed by the Official Committee of Unsecured Creditors (the “Committee”) of Hopeman Brothers, Inc. for entry of an order quashing the Rule 30(b)(6) Notice of Deposition (“Deposition Notice”) propounded by Liberty Mutual Insurance Company (“Liberty”) upon the Committee, or in the alternative, for entry of a protective order forbidding the Rule 30(b)(6) deposition sought in the Deposition Notice (the “Deposition”); and the Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that the Court may enter a final order consistent with Article III of the United States Constitution; and the Court having found that the venue of this proceeding and the Motion is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having reviewed (i) the Motion and (ii) *Liberty Mutual Insurance Company’s Opposition to Official Committee of Unsecured Creditors’ Motion to Quash Deposition Notice* [Dkt. 917]; and the Court having held a hearing to consider the Motion on June 24, 2025 (the “Hearing”); and denial of the Motion being appropriate for the reasons stated by the Court on the record at the Hearing; and after due deliberation and consideration;
