Under consideration of the *Sixth Interim Fee Application of Morgan, Lewis & Bockius LLP as Special Insurance Counsel to the Official Committee of Unsecured Creditors for the Interim Period of September 1, 2025 through November 30, 2025* (the “**Application**”);<sup>1</sup> and the Court having reviewed the Application that was served by the Committee, and finding that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, and determining that proper

and adequate notice has been given and that no other or further notice is necessary; and after due deliberation thereon; and good and sufficient cause appearing therefor,

**IT IS HEREBY ORDERED** as follows:

1. The Application is GRANTED.
2. Morgan Lewis is hereby granted interim allowance of compensation for professional services in the amount of \$41,253.40 for professional services rendered and reimbursement for expenses incurred for the period from September 1, 2025 through November 30, 2025, in the amount of \$34,889.00 in fees and \$6,364.40 in expenses.<sup>2</sup>
3. The Debtor is hereby authorized and directed to remit to Morgan Lewis all unpaid fees and expenses allowed pursuant to this Order.
4. The Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation or interpretation of this Order.
5. This Order shall be immediately effective and enforceable upon its entry.
